Examination-in-chief by APP Smt. A.K. Shaha

1. In the year 2017 I was working as a medical officer in Saibai Mote, G.H., Shegaon. My duty timing on 06.12.2017 in casualty department was 24 hours. On that day P.C. Salave B.No. 1119 had brought patient namely Sudhakar Mahaded Gavhale for medical examination. I examine the Sudhakar Mahadeo Gavhale. On examination I found the following injuries on her person.

A. Lacerated wound over occipital region of head, the size of injury is 1 cm X 0.5 cm X 0.3 cm.

B. Lacerated Wound on left toe, size of the injury is 0.6 cm X 0.3 X 0.3 cm.

C. Abrasion on little finger of left leg, size of the injury is 0.5 X 0.25 cm.

D. Contusion on back side of neck, size of the injury is 4 cm X 3 cm.

2. Age of the above mentioned injury is less than 24 hours. First, second and fourth injury can be caused by hard and blunt object. Third injury can be caused by pointed object. The healing period for first and second is approximately 7 to 10 days and healing period for the third and fourth injury was approximately 3 to 7 days. Accordingly I issued the

medical certificate. Now I am shown the medical certificate. It bears my signature. Its contents are true and correct. It is marked as **Exh. 75**. Now I am shown the requisition memo given by the police. It bears my signature. Its contents are true and correct. It is marked as **Exh. 76**. Wooden handle, Iron rod may be included in the hard and blunt object.

Cross-examination by advocate for accused Shri. B. M. Lahudkar:-

3. It is true to say that, the injury of patient Sudhakar Mahadeo Gavhale can be caused if person fell on the ground from running motorcycle or cycle.

Que. You did not examined the patient namely Sudhakar Gavhale ?

Ans. I had examined the patient who was brought by the police.

4. Witness voluntarily stated that I have mentioned the identification mark in the injury report. It is not true to say that, I have deposed falsely at the behest of the police authority. It is not true to say that, I have issued the medical certificate as per the wish and say of the police authority. It is not true to say that, whatever I deposed in examination in chief is false.
