Application for grant of legal heirship certificate under Bombay

J U D G M E N T

(Delivered on 11th day of August, 2026)

1. This application is filed for grant of heirship certificate under the provisions of Bombay Regulation Act VIII of 1827.

The case of the applicants in brief are as follows:-

2. Applicant No.1 to 4 are the children of deceased **Shaikh Jahur Shaikh Wazir**. Hence, in this way applicants are the legal heirs of deceased **Shaikh Jahur Shaikh Wazir** who died on 24.01.2017. The applicants are in need of legal heir certificate. Hence, this application.

3. In support of their contention the applicant No.1 Shaikh Akil Shaikh Jahur has examined himself by filing his affidavit at **Exh.11**. He re-iterated the contents of application. He deposed as per application and relied upon verified copy of death certificate of his father deceased **Shaikh Jahur Shaikh Wazir** at **Exh.12**, mother deceased **Khairunnisa Shaikh Jahur** at **Exh.13**. Certificate issued by Corporator, Municipal Council, Shegaon, Tq.Shegaon at **Exh.14**. Verified photocopies of Aadhar cards at **Exh.15 to 18** respectively. Paper bill and Paper publication in newspaper "Lokopchar" dated 06.07.2026 at **Exh.19 & 20** respectively. Evidence closed pursis at Exh.21.

4. The above documents shows that applicants are legal heirs of deceased **Shaikh Jahur Shaikh Wazir**. The public notice was issued in above newspaper on 06.07.2026 at Exh.20. However, none appeared and contested the case. The testimony of applicants and documents referred above corroborates contents of petition. The documentary evidence support oral testimony of applicant. No objection has been

received to the public notice issued in above newspaper. Thus, it appears that applicants are the legal heirs of deceased and they are entitled for legal heirship certificate, hence the application deserves to be allowed. Hence, I proceed to pass following order.

ORDER

1. The application is allowed.
2. Issue legal heirship certificate in the name of applicants namely Shaikh Akil Shaikh Jahur, Shaikh Jameel Shaikh Zahoor, Shaikh Shakeel Shaikh Zahoor, Ruksana Rahiskha Pathan, declaring them as the recognized legal heirs of deceased '**Shaikh Jahur Shaikh Wazir**' as provided under the provisions of Bombay Regulation Act VIII of 1827 on payment of requisite Court fees.
3. This certificate is not valid for mutation of any movable or immovable property.
