**Judgment**

(Delivered on 02/04/2026)

This is an application filed under section VIII(2) of the Bombay Regulation Act, 1827 for issuing legal heirship certificate.

2. It is submitted that the applicant No.1 is the widow of deceased Arun Pralhad Shegokar and applicant No.2 and 3 are the son of deceased Arun Pralhad Shegokar. Deceased Arun Pralhad Shegokar died on 07/02/2011 at Niramaya Hospital Chinchwad. The funeral and other right of deceased performed at permanent house of deceased at Dobel Wes, Malipura, Shegaon. The deceased was born at Shegaon and got and completed education in Shegaon. The applicants are temporary resident of Nigdi Pune. Applicants are permanent resident of Shegaon. Applicants need legal heirship certificate for Government/semi Government and other private purposes. Hence, applicants filed the present application.

3. Following points arose for my consideration for the determination of this case and my findings thereon with reason to follow.

**: REASON :**

**As to point No. 1 and 2 :**

4. The applicant No.3 and 2 has led their evidence by way of evidence affidavit (Exh.11 and 14) in support of their claim. Verified copy of death certificate (Exh.15) of deceased Arun Pralhad Shegokar disclosed that Arun Pralhad Shegokar died on 07/02/2011. Heirship certificate (Exh.18) issued by Corporator, Shailesh Daberao of M.C. Shegaon also

show that applicants are the only legal heirs of deceased Arun Pralhad Shegokar.

5. The proclamation (Exh.31) was published in daily news paper Lokopchar dated 26/08/2025 inviting objection within 30 days but none has appeared and raised objection until now. Notice inviting objection was also affixed on the notice board of Civil & Criminal Court, Shegaon, Municipal Council Shegaon and notice was also affixed on the house of the applicants. Needless to say that, the issuance of heirship certificate does not confer any right on any person in respect of property of deceased. The issuance of heirship certificate in the name of applicants is the formal recognition of the applicants as legal heirs of the deceased Arun Pralhad Shegokar and the applicants have established their said claim. Considering the documentary and oral evidence on record, I am satisfied that applicants are heirs of deceased Arun Pralhad Shegokar. Therefore, it is just and desirable to issue legal heirship certificate in favour of applicants. Hence, I answer the point No.1 and 2 in affirmative and in answer to point No.3, I proceed to pass following order.

**ORDER**

1. The application is allowed.
2. It is hereby declared that applicants are legal heirs of deceased Arun Pralhad Shegokar. Legal heirship certificate be issued in the name of applicant No.1 Smt. Rajani Arun Shegokar, applicant No.2 Shailesh Arun Shegokar and applicant No.3 Umesh Arun Shegokar, as they are the only legal heir of deceased Arun Pralhad Shegokar on payment of requisite court fees.
