**Application for grant of legal heirship certificate under Bombay
Regulation Act VIII of 1827**

J U D G M E N T

(Delivered on 15th day of April, 2026)

1. This application is filed for grant of heirship certificate under the provisions of Bombay Regulation Act VIII of 1827.

The case of the applicants in brief are as follows:-

2. Applicant No.1 is the daughter in law, No.2 is the daughter and No.3 to 7 are the grandchildren of deceased **Baban Ramchandra Gole** and deceased **Rukhmina Baban Gole**. Hence, in this way applicants are the legal heirs of deceased **Baban Ramchandra Gole** who died on 06.05.1981 and deceased **Rukhmina Baban Gole** who died on 01.03.2007. The applicants are in need of legal heir certificate. Hence, this application.

3. In support of their contention the applicant No.3 Dipak Bhaskar Gole has examined himself by filing his affidavit at **Exh.11**. He re-iterated the contents of application. He deposed as per application and relied upon verified copy of death certificates of deceased **Baban Ramchandra Gole** at **Exh.12**, deceased **Rukhmina Baban Gole** at **Exh.13**, deceased **Bhaskar Baban Gole** at **Exh.14**, deceased **Mohan Rambhau Ugale** at **Exh.15**, deceased **Shobha Mohan Ugale** at **Exh.16**. Verified photocopies of Aadhar cards at **Exh.17** to **23**. respectively. Paper bill and Paper publication in newspaper “Prashnkal” dated 26.12.2025 at **Exh.24** & **25** respectively. Evidence closed pursis at **Exh.26**.

4. The above documents shows that applicants are legal heirs of deceased **Baban Ramchandra Gole** and deceased **Rukhmina Baban Gole**. The public notice was issued in above newspaper on 26.12.2025 at **Exh.25**. However none appeared and contested the case. The testimony of applicants and documents referred above corroborates contents of petition. The documentary evidence support oral testimony of applicant. No objection has been received to the public notice issued in above newspaper. Thus, it appears that applicants are the legal heirs of deceased and they are entitled for legal heirship certificate, hence the application deserves to be allowed. Hence, I proceed to pass following order.

ORDER

1. The application is allowed.
2. Issue legal heirship certificate in the name of applicants namely

Ushabai Bhaskar Gole, Mina Janardan Nile, Dipak Bhaskar Gole, Sunanda Ganesh Tale, Kiran Mohan Ugale, Yogita Umesh Umale, Arti Sachin Dhage, declaring them as the recognized legal heirs of deceased '**Baban Ramchandra Gole** and deceased **Rukhmina Baban Gole**' as provided under the provisions of Bombay Regulation Act VIII of 1827 on payment of requisite Court fees.

3. This certificate is not valid for mutation of any movable or immovable property.
