Judgment

(Delivered on 10/04/2026)

This is an application filed under section VIII(2) of the

Bombay Regulation Act, 1827 for issuing legal heirship certificate.

2. It is submitted that the applicant No.1 is the widow of deceased Diliprao Baburao Chavan and applicant No. 2 to 4 are the daughters of deceased Diliprao Baburao Chavan. Deceased Diliprao Baburao Chavan died on 27/07/2019 at Matargaon Bk., Tq. Shegaon, Dist. Buldana. Applicant No.1 to 4 are the only legal heirs of deceased Diliprao Baburao Chavan. Applicants need legal heirship certificate for Government/semi Government and other private purposes. Hence, applicants filed the present application.

3. Following points arose for my consideration for the determination of this case and my findings thereon with reason to follow.

: REASON :

As to point No.1 and 2 :

4. The applicant No.1 has led her evidence by way of evidence affidavit (Exh.11) in support of their claim. Original copy of death certificate (Exh.12 and 13) of deceased Diliprao Baburao Chavan and deceased Shalini Baburao Chavan disclosed that they are dead. Heirship certificate (Exh.14) issued by Sarpanch Grampanchayat Matargaon Bk., Tq. Shegaon, Dist. Buldana also show that applicants are the only legal

heirs of deceased Diliprao Baburao Chavan.

5] The proclamation (Exh.19) was published in daily news paper Prashnakal dated 01/01/2026 inviting objection within 30 days but none has appeared and raised objection until now. Notice inviting objection was also affixed on the notice board of Civil & Criminal Court, Shegaon and Grampanchayat Matargaon Bk. and notice was also affixed on the house of the applicants. Needless to say that, the issuance of heirship certificate does not confer any right on any person in respect of property of deceased. The issuance of heirship certificate in the name of applicants is the formal recognition of the applicants as legal heirs of the deceased Diliprao Baburao Chavan and the applicants have established their said claim. Considering the documentary and oral evidence on record, I am satisfied that applicants are heirs of deceased Diliprao Baburao Chavan. Therefore, it is just and desirable to issue legal heirship certificate in favour of applicants. Hence, I answer the point No.1 and 2 in affirmative and in answer to point No.3, I proceed to pass following order.

ORDER

1. The application is allowed.
2. It is hereby declared that applicants are legal heirs of deceased Diliprao Baburao Chavan. Legal heirship certificate be issued in the name of applicant No.1 Anita Dilip Chavan, applicant No.2 Nikita Dilip Chavan, applicant No.3 Sneha Vijay Ingle and applicant No.4 Bhavana Dilip Chavan, as they are the only legal heir of deceased Diliprao Baburao Chavan on payment of requisite court fees.
