Application for grant of legal heirship certificate under Bombay
Regulation Act VIII of 1827

J U D G M E N T

(Delivered on 22nd day of April, 2026)

1. This application is filed for grant of heirship certificate under the provisions of Bombay Regulation Act VIII of 1827.

The case of the applicants in brief are as follows:-

2. Applicant No.1 to 4 are the children, No.5 is the daughter in law and No.6 to 10 are the grandchildren of deceased **Shriram Sampat Gadhe** and deceased **Narmadabai Shriram Gadhe**. Hence, in this way Applicants are the legal heirs of deceased **Shriram Sampat Gadhe** who died on 13.12.1996 and deceased **Narmadabai Shriram Gadhe** who died on 26.01.2009. The applicants are in need of legal heir certificate. Hence, this application.

3. In support of their contention the applicant No.8 Varsha @ Vijaya Devidas Ingle has examined herself by filing her affidavit at **Exh.13**. She re-iterated the contents of application. She deposed as per application and relied upon verified copy of death certificates of deceased **Shriram Sampat Gadhe** at **Exh.14**, deceased **Narmadabai Shriram Gadhe** at **Exh.15**, deceased **Shaligram Shriram Gadhe** at **Exh.16** and deceased **Sumitra Manohar Ghyar** at **Exh.17**. Certificate issued by Sarpanch, Grampanchayat, Matargaon, Tq.Shegaon at **Exh.18 to 21**. Verified photocopies of Aadhar cards at **Exh.22 to 31**. respectively. Paper bill and Paper publication in newspaper "Lokopchar"

dated 23.01.2026 at **Exh.32 & 33** respectively. Evidence closed pursis at Exh.34.

4. The above documents shows that applicants are legal heirs of deceased **Shriram Sampat Gadhe** and deceased **Narmadabai Shriram Gadhe**. The public notice was issued in above newspaper on 23.01.2026 at Exh.33. However none appeared and contested the case. The testimony of applicants and documents referred above corroborates contents of petition. The documentary evidence support oral testimony of applicant. No objection has been received to the public notice issued in above newspaper. Thus, it appears that applicants are the legal heirs of deceased and they are entitled for legal heirship certificate, hence the application deserves to be allowed. Hence, I proceed to pass following order.

ORDER

1. The application is allowed.
2. Issue legal heirship certificate in the name of applicants namely Chandrakala Atmaram Phate, Lila Pralhad Kokate, Shashikala Shantaram Fate, Sulochna Bhagvat Bakal, Shakuntala Shaligram Gadhe, Vijay Shaligram Gadhe, Omkar Shaligram Gadhe, Varsha @ Vijya Devidas Ingle, Rajesh Manohar Ghyar, Vrushali Wasudeo Shejol, declaring them as the recognized legal heirs of deceased '**Shriram Sampat Gadhe** and deceased **Narmadabai Shriram Gadhe**' as provided under the provisions of Bombay Regulation Act VIII of 1827 on payment of requisite Court fees.

3. This certificate is not valid for mutation of any movable or immovable property.
