**Application for grant of legal heirship certificate under Bombay
Regulation Act VIII of 1827**

J U D G M E N T

(Delivered on 11th day of March, 2026)

1. This application is filed for grant of heirship certificate under the provisions of Bombay Regulation Act VIII of 1827.

The case of the applicants in brief are as follows:-

2. Applicant No.1 is the wife and applicant No.2 to 5 are the children of deceased **Muralidhar Ramchandra Ratale**. Hence, in this way applicants are the legal heirs of deceased **Muralidhar Ramchandra Ratale** who died on 18.11.2024. The applicants are in need of legal heir certificate. Hence, this application.

3. In support of their contention applicant No.2 Santosh Muralidhar Ratale has examined himself by filing his affidavit at **Exh.11**. He re-iterated the contents of application. He deposed as per application and relied upon verified copy of death certificate of his father deceased **Muralidhar Ramchandra Ratale** at **Exh.12**. Certificate issued by Sarpanch, Grampanchayat, Bhongaon, Tq.Shegaon at **Exh.13**. Verified photocopies of Aadhar cards at **Exh.14 to 18** respectively. Paper bill and Paper publication in newspaper "Lokopchar" dated 13.01.2026 at **Exh.19 & 20** respectively. Evidence closed pursis at **Exh.21**.

4. The above documents shows that applicants are legal heirs

of deceased **Muralidhar Ramchandra Ratale** who died on 18.11.2024. The public notice was issued in "Lokopchar" newspaper on 13.01.2026 at Exh.20. However none appeared and contested the case. The testimony of applicants and documents referred above corroborates contents of petition. The documentary evidence support oral testimony of applicant. No objection has been received to the public notice issued in above newspaper. Thus, it appears that applicants are the legal heirs of deceased and they are entitled for legal heirship certificate, hence the application deserves to be allowed. Hence, I proceed to pass following order.

ORDER

1. The application is allowed.
2. Issue legal heirship certificate in the name of applicants namely Sumanbai Muralidhar Ratale, Santosh Murlidhar Ratale, Dhanraj Muralidhar Ratale, Indubai Manikrav Sultane, Sangita Shriram Indore, declaring them as the recognized legal heirs of deceased '**Muralidhar Ramchandra Ratale**' as provided under the provisions of Bombay Regulation Act VIII of 1827 on payment of requisite Court fees.
3. This certificate is not valid for mutation of any movable or immovable property.
