Age – 38 years, Occupation – Agriculture,
- 2) **Shriram Bhikaji Vitokar,**
Age – 66 years, Occupation – Agriculture,
- 3) **Sau. Kesarbai Shriram Vitokar,**
Age – 63 years, Occupation – Agriculture,
- 4) **Gokulabai d/o Shriram Vitokar,**
Age – 40 years, Occupation – Agriculture,
- 5) **Gajanan Shriram Vitokar,**
Age – 45 years, Occupation – Agriculture,
- 6) **Sau. Sharda Gajanan Vitokar,**
Age – 41 years, Occupation – Agriculture,

All R/o. Kati, Tal. Nandura, Dist. Buldhana.

as follows :

That, since after one and half months from the date of marriage at village Kati, Tal. Nandura, Dist. Buldhana you accused No. 1 being husband of informant, accused Nos. 2 to 7 being relatives of husband of the informant in furtherance of your common intention subjected her to cruelty and thereby committed an offence punishable under Section 498-A read with Section 34 of the Indian Penal Code and within my cognizance.

2. That, after the informant conceived and specifically on 28/07/2015 at your house in the above referred village, you all accused in furtherance of your common intention voluntarily caused hurt to informant Tai Mohan Vitokar by beating her and thereby committed an offence punishable under Section 323 read with Section 34 of the Indian Penal Code and within my cognizance.

3. That after the informant conceived and specifically on 28/07/2015 at your house in the above referred village, you all accused in furtherance of your

common intention committed of criminal intimidation by threatening to informant Tai Mohan Vitokar and thereby committed an offence punishable under Section 506 read with Section 34 of the Indian Penal Code and within my cognizance.

4. That, between 23/02/2015 to 28/07/2015, at the time when the informant Tai Mohan Vitokar was pregnant, at above referred village in your house, you all accused in furtherance of your common intention caused miscarriage of the informant without her consent and thereby committed an offence punishable under Section 313 read with Section 34 of the Indian Penal Code and within my cognizance.

5. That, between 23/02/2015 to 28/07/2015 at your house in above referred village, you accused No. 2 uses criminal force against the informant Tai Mohan Vitokar intending to outrage her modesty and thereby committed an offence punishable under Section 354 of the Indian Penal Code and within my cognizance.
