CHARGE

I, Sanjaykumar V. Jadhav, Additional Sessions Judge, Malkapur hereby charge you,

1. **Rajendra @ Raju Uttamsingh Umalkar,**
Age – 50 Years, Occu. - Agriculturist Labour,
2. **Anita @ Annapurna Rajendra @ Raju Umalkar,**
Age – 44 Years, Occu. - Agriculturist Labour,
Both resident of Tighra, Taluka- Malkapur,
District- Buldhana.

as follows,

That on or about 06/08/2018 at about 8:30 a.m. at village Tighra, Taluka- Malkapur, District- Buldhana in furtherance of your common intention, on the bullock cart way from the field of the informant – Kailas Dama Kalaskar to the village you committed obscene act at a public place of hurling abuses and thereby committed an offence punishable under section 294 read with section 34 of the Indian Penal Code and within my cognizance.

Secondly, that on the aforesaid date, time and place you accused, in furtherance of your common intention voluntarily caused hurt to the informant by means of sharp agricultural instrument used for cutting grass and which if used as a weapon likely to caused death and thereby committed an offence punishable under section 324 read with section 34 of the Indian Penal Code and within my cognizance.

Thirdly, that on aforesaid date, time and place you both accused, in furtherance of your common intention, committed intentional insult of the informant provoking him with intention or knowledge such provocation would cause him to break public peace or to commit any other offence and thereby committed an offence punishable under section 504 read with section 34 of the Indian Penal Code and within my cognizance.

Fourthly, that on aforesaid date, time and place you both accused in furtherance of your common intention threatened the informant of causing injury to him and thereby committed an offence punishable under section 506 read with section 34 of the Indian Penal Code and within my cognizance.

Fifthly, that on aforesaid date, time and place you both the accused not being the members of Scheduled Cast or Schedule Tribe intentionally insulted or intimidated the informant by name Kailas Dama Kalaskar who is a member of Scheduled Cast with intent to humiliate him in a place within public view and thereby committed an offence punishable under section 3(1)(r) of the Scheduled Cast and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and within my cognizance.

Sixth, that on aforesaid date, time and place you all the accused not being the members of Scheduled Cast or Schedule Tribe abused the informant by name Kailas Dama Kalaskar who is the member of Schedule Cast in a place within public view and thereby committed an offence punishable under section 3(1)(s) of the Scheduled Cast and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and within my cognizance.

Lastly, that on aforesaid date, time and place you accused not being the member of Scheduled Cast or Schedule Tribe committed offence punishable under section 324, 506 of the Indian Penal Code as mentioned in the Schedule annexed to the S.C. and S.T. (Prevention of Atrocities) Act against the informant by name Kailas Dama Kalaskar knowing that he is the member of Schedule Cast and thereby committed an offence punishable under section 3(2)(va) of the Scheduled Cast and Scheduled Tribes (Prevention of Atrocities) Act, 1989 and within my cognizance.

And I hereby direct that you be tried me for the above said offences.
