-: JUDGMENT :-

(Delivered on this 14th Day of March, 2026)

1. The P.S.O., Deulgoan Raja charge-sheeted the accused for the offence punishable U/s 12-A of the Maharashtra Prevention of Gambling Act.
2. The particulars of the above offence read over and explained to the accused in vernacular to which the accused voluntarily pleads guilty of the said offence. The plea of the accused being voluntary and unconditional, I accept the same and hold accused guilty of the offence punishable U/s 12-A of the Maharashtra Prevention of Gambling Act. It appears that this is first offence committed by the accused. The punishment provided for the alleged offence fine which may extend to Rs. 300/- and imprisonment which may extend to three months. The accused prayed for leniency. Considering the fact that the accused was involved in the alleged offence, an opportunity may be given to him. Hence, I pass the following order.

ORDER

1. Accused **Somnath Sakharam Waghmare**, is hereby convicted for the offence punishable under section U/s 12-A of the Maharashtra Prevention of Gambling Act vide section 252 of Cr. P. C. and he is sentenced to suffer imprisonment till rising of the Court and to pay fine of Rs. 300/- (Rupee Three hundred only) in default to suffer S.I. of 02 days.
2. The seized muddemal property i.e. cash of Rs. 400/- be forfeited and credited to the Government.
3. The other muddemal i.e. worli matka chits and one dot pen being worthless be destroyed after appeal period is over.
