That on 30.01.2026 at about 18:30 you accused, by parking your Auto bearing No. MH-30-B-6391 in front of Bus stand Chauk Lonar, Tq. Lonar, created obstruction in the public way which was dangerous to the public and thereby committed an offence punishable u/s 285 of Bharatiya Nyaya Sanhita, 2023 and within my cognizance.

**ORDER ON PLEA GUILTY**

01. The present matter is registered on 11.03.2026 as a summary case. The accused is alleged to have committed an offence

punishable under Section 285 of the Bharatiya Nyaya Sanhita, 2023.

**02.** Accused appeared before Court suo motu. He has filed a pursis at Exh.2. He has also produced his original Aadhar Card for verification. Satisfied that the person present before the court is the same against whom the case is registered. The particulars of the offence are read over and explained to accused in his language. After fully understanding the contents of the particulars, the accused plead guilty. He has admitted his guilt. It is also stated by him that he voluntarily wants to plead guilty. Accused prayed for lenient view.

**03.** Accused submitted that he has not committed any offence of similar nature in past. He submitted that he will not commit similar or any other offence in future. He submitted that he is the only earning hand of his family. His financial condition is weak. I have considered nature of offence, age of the accused and his financial condition. I am of the view that, accused is entitled for Lenient view. Hence, the order.

**-O R D E R-**

Accused **Rais Khan Habib Khan**, is convicted for offence punishable u/s **285 of Bharatiya Nyaya Sanhita, 2023** vide Sec. 275 of Bharatiya Nagarik Suraksha Sanhita, 2023 and accused is sentenced to pay a fine of **Rs. 200/-** in word **(Rs. Two Hundred Only)**. **I.D.S.I. for 1 day.**
