02] It is the case of prosecution that Ankit Patel is the owner of M/s Dinesh Kumar Kantilal Grain Trading Company. Informant Ajaysinh Aanandsinh Waghela is serving as a driver for Ankit Patel.

1,80,000/-, one country-made pistol along-with four cartridges worth of Rs. 24,000/-, one Mahindra Bolero car bearing Registration No. MH-24-BL-1411 approximately amount of Rs. 5,00,000/-, one silver-grey vehicle without number plate approximately amount of Rs. 5,00,000/-, four mobiles approximately worth of Rs. 40,000/- and two Wi-Fi devices approximately worth of Rs. 4,000/- from the possession of accused persons.

04] Perused the application and heard the learned Advocate for applicant Mr. D. J. Qureshi. He submitted that the accused is arrested on 04.05.2026. Remanded to police custody till 15.05.2026 and thereafter, sent to magisterial custody. The complaint is false. The applicant has not committed any offence. There is no evidence against him. The accused is resident of Ambajogai, Dist. Beed. He was arrested from the house. He was not present when the alleged offence took place. He has not contacts with the absconding accused persons. Nothing remained to recover. It is submitted to release him on bail.

05] The application is opposed by the Investigating Officer by filing say at Exh. 5 contending that the accused persons chased the vehicle of the complainant from Nagpur. The vehicle was carrying Rs. 12,00,000/- to be taken to Unjha, Gujarat. The accused robbed the complaint of Rs. 12,00,000/- near Dusarbid Toll Naka

on Samruddhi Highway on the point of pistol. They also assaulted the complainant by abandoning the complainant and witness Raghuvirsingh Solanki in a forest near Jalna. Out of the robbed amount of Rs. 12,00,000/- only Rs. 1,80,000/- are recovered. The remaining amount is not yet seized. It is further submission of the Investigating Officer that the accused are harden criminals. Offences of murder and robbery are registered against them. If the accused is released, he will commit serious offence.

06] I have heard the argument advanced by both the sides. The learned Advocate for the applicant argued that the accused has no concerned with the present trial. He was arrested from Beed. He is not in contact with absconding accused. The accused has no criminal antecedent. The accused is sufficiently interrogated during police custody, his further custodial interrogation is not required.

07] The learned A.G.P. Shri. S. P. Hiwale argued that the offence is of serious nature. The accused pre-mediated, chased the complainant. When the vehicle was stopped, they robbed Rs. 12,00,000/- on the point of pistol from the complainant and witness. They also assaulted the complainant and witness. The investigation is in progress. The role of the accused person is revealed from C.C.T.V. Footage. If accused is released, he will repeat the offence.

08] I have perused the F.I.R., say of Investigating Officer and

case diary. It prima-facie reveals that the present applicant and other accused persons who were not yet arrested, committed robbery of Rs. 12,00,000/- from the vehicle of the complainant. The said cash was relating to business and to be taken to Unjha, Gujarat. Near Dusarbid Toll Plaza the accused persons committed robbery of the said amount, threatened the complainant and witness on the point of pistol and also assaulted them. It is to be noted that an amount of Rs. 1,80,000/- is recovered and remaining amount out of Rs. 12,00,000/- yet to be seized. The other accused persons involved in the offence are not yet arrested. Thus, the investigation is in progress. If the accused is released, he will facilitate the other accused to remain abscond and the remaining amount of robbery would not be recovered, hence, it is not justified to release the accused on bail. Therefore, following order.

- O R D E R -

Regular Bail Application No. 160/2026 is rejected.
