Fresh *vakalatnama* filed on behalf of the petitioner Salman in MACT
No. 89/25.

IO has filed dasti copy of the order dated 30.03.2026, passed by Ld.
JMFC-12, Central District, Tis Hazari Courts, Delhi and submits that the untrace
report is in respect of the FIR No. 597/2024, PS Wazirabad, under Section 281/125(a)
BNS, which is in respect of a hit and run accident. He further submits that untrace
report has already been filed before Ld. JMFC-12, Central District, Tis Hazari
Courts, wherein the statement of Mr. Salman i.e. father of the injured Alshifa,
husband of injured Nazreen as well as injured himself in MACT No. 89/25 has been
recorded and the untrace report has been accepted with directions that the file be sent
to the concerned police station and be reopened as and when any clue is found.

Mr. Salman submits that he has gone through the DAR and he does
not wish to file any protest petition in respect of the DAR as filed, since he is satisfied
with the investigation carried out in the hit and run accident and he does not have
any information about the registration number of the offending vehicle or about the

identity of its driver as both are unknown. He further submits that the injured Nazreen is unable to appear physically as she is still undergoing treatment.

Separate statement of Mr. Salman has been recorded in respect of the same in all three cases.

Heard. Record perused.

Untrace report is stated to have already been accepted by the Court of Ld. JMFC-12, Central District, Tis Hazari Courts on 30.03.2026. Dasti copy of the said order has also been filed.

In view of statement of Mr. Salman and also considering the fact that the untrace report has already been accepted by Ld. JMFC-12, in view of the relevant material filed along with the DAR as per which the driver and owner of the offending vehicle are unknown, the DAR as filed is accepted as untraced.

File be consigned to the Record Room as sine-die. It be revived as and when the whereabouts of the driver and owner of the offending vehicle are traced.

Injured/Mr. Salman has been informed about the Victim Compensation Scheme. All three injured are at liberty to approach the office of DLSA (Central), at Room No. 287, Tis Hazari Courts, Delhi for compensation as per rules.

On request, copy of this order be given *dasti*.
