



**ORDER BELOW EXH.1**  
**(Dated 16/06/2026)**

This is an application for seeking legal heir-ship certificate under the Bombay Regulation Act No. VIII, 1827. The applicant no.1 is widow, applicant 2 is son of deceased **Nago @ Nagoba Bapurao Bhoyar** who expired on 24/08/2021 at Ballarpur, Tah. Distt. Chandrapur. The applicant no. 2 is brother of deceased Pravin Nago @ Nagoba Bhoyar who expired on 15/06/2024. Applicants are in need of legal heirship certificate for academic purpose. Hence, they prayed for issuing legal heir-ship certificate in their favour.

- 2] Read the contents of the application, affidavit of applicant no.1 Meera Nago @ Nagoba Bhoyar has filed at **Exh.11** and perused the documents on record.
- 3] Heard the learned Advocate for the applicants.
- 4] Public notice and proclamation has been issued. No one has appeared to challenge the contents of application and affidavit at **Exh.11** filed by applicants. The Death certificate of deceased **Nago @ Nagoba Bapurao Bhoyar** are at **Exh.12** and Aadhar cards of deceased at **Exh. 13**. Aadhar cards of applicant no.1 and 2 are at **Exh.17 to 18** respectively. At **Exh. 25** applicant has filed gazetted copy. After perusal of gazetted copy it is clear that Kameshwar Nago Bhoyar (old Name) name is gazetted as Pradip Nagoba Bhoyar(New Name) both name are carried by one and same person.
- 5] Despite issuance of paper publication, nobody has turned up before this Court and contested this application. The receipt of paper publication dated 23/01/2026 (Navrashtra) is at **Exh.20**. The contents of

affidavit at **Exh.11** have remained uncontroverted. There is no reason to disbelieve the version of applicant no.1 on oath. Therefore, having perused the affidavit and connected documents with meticulous care, I am satisfied that applicant no.1 Meera Nago @ Nagoba Bhoyar , applicant no.2 Pradip @ Kameshwar @ Nago @ Nagoba Bhoyar are class-1 legal heirs of deceased **Nago @ Nagoba Bapurao Bhoyar**. All the procedural requirements are complied with and I find no justifiable reason to reject the application. In the result, I pass the following order.

**: O R D E R :**

1. This application is hereby allowed.
2. Issue heir-ship certificate in the name of the applicant no.1 Meera Nago @ Nagoba Bhoyar , applicant no.2 Pradip @ Kameshwar Nago @ Nagoba Bhoyar as class-1 legal heirs of deceased **Nago @ Nagoba Bapurao Bhoyar** as per section 2 of the Bombay Regulation Act VIII, 1827 on payment of requisite Court Fee, if required to pay any, as per law.
3. The note shall be appended to the certificate as per Bombay Regulation Act No. VIII, 1827 and as provided at Para 312 of the Civil Manual.
