

Deposition of witness No. 07 for the prosecution.

I do hereby solemn affirmation on oath state that :-

Age - 42 Yrs., Occ. – Medical Officer,

R/o - Sub District Hospital, Warora, Tah.Warora, Dist.Chandrapur

01. On 10/07/2021, I was posted as M.O. at Rural Hospital, Bhadrawati. On that day, B.No.2494 brought injured namely Amish Ashokrao Maind for medical examination. The N.P.C.2700 issued letter to me, have received the same. The letter shown to me bears my signature. The contents are true. It is at **Exh. 44.**

02. I have examined the injured and found following injuries:-

- 1) Contused abrasion on right forearm, lower end posteriorly region, size 1 X 0.5 c.m., the injury was simple in nature, it was fresh, it was caused by hard and blunt object, healing time was 5-7 days.
- 2) Contusion, epigastric region of stomach, size 4 x 2 c.m., the patient was referred for further examination, therefore the nature of injury was kept reserved, the injury was fresh, it was caused by hard and blunt object, healing time was 5-7 days.

03. After examination I have issued certificate. The certificate shown to me bears my signature along with the seal of hospital, signature of constable and injured respectively. The contents are true. It is at **Exh.45.** I have referred the patient and for that purpose issued refer slip. That slip bears my signature, the contents are true. It is at **Exh.46.** The I.O. has issued letter for query of seized weapon. The letter shown to me bears signature of I.O. I have gone through that letter and after examination of weapon gave my opinion accordingly. The contents of letter are true. It is at **Exh.47.** The seized property wooden stick was

brought before me for query. The details are-length 75 cm., circumference- at middle 11 cm., one end square, another circular end. I have opined that, the injuries stated at Injury Certificate may be caused by said object. The contents of Query are true. It is at **Exh.48**. I can identify the property if shown to me. Article-A one stick is the same weapon. It bears my signature and the weapon was sealed by our hospital.

04. The letter Exh.44 is issued by B.No.2700. The name is not stated in that letter that's why I cannot depose the name of that person. The witness volunteers that his name is (P.C.) Nikesh. His surname is Dhenge. I have taken the entry of that letter at our hospital register. It is true to say that, I have not bring the document bears that entry along with me as well as not given it to concerned I.O. for filing it along with the charge-sheet. It is not true to say that, the entry regarding that letter taken at concern register is false. It is true to say that, I have not inquired about the person who have issued that letter. It is true to say that, injuries stated at Injury Certificate could be possible if someone fallen on hard and blunt object.

Que.-At Exh.46 there is no any endorsement regarding receive of the same ?

Ans.-In routine course, there is no such endorsement regarding receiving of the same.

05. It is true to say that, the document on which endorsement of received is not with me. It is not true to say that, I have not handover the Exh.46 to anyone that's why there is no any document in that regard

with me. It is true to say that, at Exh.44 there is no endorsement regarding receiving of the same. It is not true to say that, Amish Maind was brought to me for medical examination and after examination, I have issued MLC report in that regard is false. It is not true to say that, I have prepared the Report, Query Report as per requirement sought by the police. It is not true to say that, person namely Amish Maind had not came to me for medical examination and I have issued false certificate. I have not taken entry regarding the weapon sealed by our hospital. It is not true to say that, no any property bring for Query Report to me and I have issued false Query Report as per say of Police Officer.
