; JUDGMENT ON PLEA OF GUILTY;
(Delivered On 18th of July, 2026).

The accused No. 2 is present today and he has tendered pursis at Exh-2 whereby he admits the guilt for offence punishable under section 12 (a) of the Bombay Prevention of Gambling Act.

2. In pursuant thereto, the punishment provided for offence has been explained to him, he has been made aware that he may be punished with the Fine of Rs. 300/- (Rupees Three Hundred Only) and imprisonment extend to three months. The accused No.2 submits that he is ready to deposit the fine amount and prayed to grant leniency in awarding punishment.

3. Though, the punishment includes imprisonment as well as fine, however, there is nothing on record to indicate that the accused No.2 has any previous criminal antecedents. Furthermore, the offence is summary in nature and in such circumstances awarding whole punishment would be against the principle of reformatory theory.

4. Consequently, the following order.

ORDER

- i. The accused No.2 is hereby convicted for the offence punishable under section 12 (a) of the Bombay Prevention of Gambling Act, vide Section 275 of the Bharatiya Nagarik Suraksha Sanhita, 2023.
- ii. The accused No.2 is hereby sentenced to undergo imprisonment till rising of the court and pay fine of Rs. 300/-.
- iii. In default of payment of fine the accused No.2 shall suffer simple imprisonment for 15 days.
- iv. The trial is continued against rest of accused.
