ORDER BELOW EXH.1

By this application applicant/accused seeks his enlargement on bail under Section 483 of Bhartiya Nagarik Suraksha Sanhita, 2023 in connection with Crime No. 11/2026 registered with West Thalner Police Station, for the offences punishable U/s. Sections 329 (4), 74 of BNS and Sections 3 (1) (w) (i), 3 (1) (w) (ii), 3 (2) (va), of The Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989.

02. I have gone through the grounds submitted by the applicant, the say filed by investigation officer through prosecution at Exh.4 and the say filed by original informant vide Exh. 5.

03. Prosecution case is that Victim Rayabai lodged report in Thalner Police Station on 15/02/2026 alleging that on 14/02/2026 at about 9:00 pm she was sleeping on a cot in her house situated at village Taradi, tal. Shirpur in bhil vasti. At that time accused knowing that the victim is belonging to Adiwasi

community, committed house-trespass and illegally entered in her house and used criminal force by moving his hand on her breast, pressed her breast with intent to outrage her modesty. Therefore, victim lodged report against the accused.

04. Heard learned Advocate for applicant Mr. S. S. Sonawane and learned APP Mr. N. B. Kalal.

05. I have gone through the FIR. The applicant is behind bars since 15/02/2026. Nothing is required to be seized from his possession considering the nature of allegations. He is resident of Ruppikhar, Bihar where as the victim is resident of Taradi Tal. Shirpur Dist. Dhule. At present applicant is working at pharmacy college construction site Taradi. Therefore, suitable conditions can be imposed on the applicant to address the apprehension of victim that there is possibility of pressurizing her by the applicant if he is enlarged on bail. Material investigation is completed. Further incarceration of the applicant is thus unwarranted. Thus, in the facts and circumstances of the case, I am of the opinion that no purpose will be served by keeping him behind bars. Resultantly, I pass following order.


ORDER

- (1) Application is allowed.
- (2) Applicant/accused **Brijendrakumar Ramadhin Yadav**, be released on bail on furnishing Personal Bond of **Rs.25,000/- (Rs. Twenty Five Thousand Only)** along

with one local surety in the like amount, in connection with C.R. No. 11/2026 registered with Thalner Police Station, for the offences punishable under Sections 329 (4), 74 of BNS and Sections 3 (1) (w) (i), 3 (1) (w) (ii), 3 (2) (va), of The Scheduled Castes and the Scheduled Tribes (Prevention of Atrocities) Act, 1989 on the following conditions:

- (i) He shall not tamper with prosecution evidence.
- (ii) He shall submit his proof of residence / Aadhar Card along with the details of mobile numbers of his two close relatives in the Court and in concerned police station.
- (iii) Violation of any conditions above, will be a ground for cancellation of bail.
- (iv) Bail order be informed to the applicant through Jail authority by E-mail.
