

ORDER BELOW EXH.1 IN MACP No. 526/2022
(Mahesh Yuvaraj Sadarao V/s. Jafruddin Jormal Balepeer
Chilawali, etc.-3)

Petitioner along with his advocate, and learned advocate for respondent No. 3 Insurance Company is also present. The advocate for Petitioner has submitted that matter is amicably settled between the parties. The matter was referred to Mediator for exploring the chances of amicable settlement. Judge mediator Mr. G. B. Gurav, District Judge-1 & Member MACT, Dhule, has reported that matter is amicably settled between the parties.

2. The petitioner has agreed to accept **Rs. 24,00,000/- (Rs. Twenty Four Lakhs only)** as full and final settlement including costs, interest and medical expenses. Respondent No. 3 Bajaj Allianz General Insurance Co. Ltd., has agreed to pay Rs. 24,00,000/- within two months. Petitioner do not want to proceed the matter against Respondent Nos. 1 & 2. Hence, the following order.

ORDER

Claim petition is allowed in terms of compromise *pursis* at Ex.64.

2. Respondent No. 3 Bajaj Allianz General Insurance Co. Ltd., shall pay **Rs. 24,00,000/- (Rs. Twenty Four Lakhs Only)** within two

months from the date of passing of this order. In default of payment within two months, the amount shall carry future interest at the rate of 6% per annum.

3. The compensation amount be paid to the petitioner by directly crediting it in his bank account by R.T.G.S./N.E.F.T.

4. Petitioner is directed to furnish following details on separate sheet along with photocopy of first page of his / her Bank Passbook containing his / her photograph and PAN Card, (if any). :-

(i)	Full name of the claimant with current address ;	
(ii)	Name of the Bank & Branch	
(iii)	Bank IFSC Code	
(iv)	Bank Account Number of claimant.	

5. Petitioner is directed to personally remain present at the time of furnishing the above said information for personal verification.

6. Respondent No. 3 Insurance Company, is directed to deposit the aforesaid amount in the following account of this Tribunal :-
