**ORDER BELOW EXH.24**

The present application has been filed by accused no.01 Mahesh @ Ghanshyam Prakash Pawar for transfer him Central Jail, Nashik to in District Prison, Dhule in view of proceed and conclude the impugned case expeditiously. The say of prosecution has been called, however they failed to submit their. Thereby present application proceeded without say of prosecution.

By this application the accused no.1 is seeking the relief of his transfer from Central Jail, Nashik to in District Prison, Dhule in view of proceed and conclude the impugned case expeditiously, effectively in his presence. The record shows in impugned crime in all eight accused are involved. Against them serious in nature's allegation for commission of crime of murder and The Maharashtra Control of Organised Crime Act, 1999 have been levelled. The certain accused are already detained in District Prison, Dhule. The present trial required to be proceed, conduct and conclude

expeditiously. Due to detention of present accused in Central Prison, Nashik certainly there would cause any hurdle, inconvenience, difficulty for his for his appearance either physically or through Video Conferencing to proceed with the trial effectively and expeditiously. ### **ORDER**

1. The present application below Exh.24 is hereby allowed.

The Superintendent of Nashik Central Prison is hereby directed to transfer, shift the accused namely; no.01 Mahesh @ Ghanshyam Prakash Pawar, who is detained in their jail in the crime vide C.R.No.275 of 2023 dated 09.10.2023, registered with Azadnagar police station, Dhule for commission of crime under Sections 302, 364, 143, 147, 148, 149, 323, 504, 506, 120(B), 109, 75, 201, 109, 212 of The Indian Penal Code, 1860, under Section 37(1)(3)/135 of the Maharashtra Police Act, 1951 and under Sections 3(1)(i), 3(2), 3(4) of The Maharashtra Control of Organised Crime Act, 1999, in the registered Special (MCOCA) Case No.95 of 2024 in Dhule District Prison at earliest.
3. The under trial prisoners-accused N0.01 is hereby directed that he shall not take any disadvantage of this order by committing any indecent objectional act conduct, behave in the

District Prison, Dhule by which the Superintendent of said Jail could face any problem, difficulty by any manner.

4. The copy of impugned order be forwarded to the Superintendent of Central Jail Nashik and District Prison Dhule urgently for compliance of this order immediately.

5. The present application below Exh.24 is hereby disposed off.
