Order Below Exh. 1 in R.C.C. No. 26/2024

(Passed on 09.03.2026)

The officer-in-charge of Dondaicha, Police Station has filed charge-sheet vide section 173(3) of the Code of Criminal Procedure, after completion of the investigation in C.R. No.252/2022 against the accused no. 1 Roshan Shaikh Abdul Nabi and accused no. 2 Afzal Shah Mustan shah. Today, the accused no. 1 and 2 are present before me.

The accused no. 1 and 2 are alleged to have committed offences punishable under sections 26 (2) (iv), 27 (3) (d), 27 (3) (e), 30 (2) (a), 3(1)(zz)(i), 3(1)(zz)(v) r.w. 59(i) of the Food Safety and Standards Act, 2006 along-with sections 328, 188, 277 and 273 of the Indian Penal Code. The offence punishable under section 328 of the I.P.C. is triable exclusively by the Court of Sessions. The provisions of section 207 of the Code of Criminal Procedure are complied with, by supplying the accused no. 1 and 2 with the copies of the Police Report, documents and statements of witnesses etc. as specified in that section. A pursis to that effect is filed at Exh.3. The accused no. 1 and 2 are represented by learned advocate of their own choice. They do not desire to avail free legal aid services. Thus, the case is fit to be committed for trial to the Hon'ble Court of Sessions, Dhule, Tal. Dist. Dhule. Hence, the following order is passed :-

:- ORDER :-

- i) The present case i.e. R.C.C. No. 26/2024 be committed to the Hon'ble Court of Sessions, Dhule, Tal. Dist. Dhule, vide

section 209 of the Criminal Procedure Code.

- ii) The accused no. 1 and 2 shall remain present before the Hon'ble Court of Sessions, Dhule, Tal. Dist. Dhule, on 29/04/2026.
- iii) The record of the case and the documents and the articles, if any, which are to be produced in the evidence be forthwith sent to the Hon'ble Court of Sessions, Dhule, Tal. Dist. Dhule.
- iv) The Officer in Charge, Dondaicha police station is directed to produce muddemal property, if any, before the Hon'ble Court of Sessions, Dhule, Tal. Dist. Dhule on or before 29/04/2026 positively.
- v) The learned Public Prosecutor be notified of the committal of the case to the Hon'ble Court of Sessions, Dhule, Tal. Dist. Dhule.
