JUDGMENT

Accused is charged for the offence under section 285 of the Bharatiya Nagarik Suraksha Sanhita, 2023. The accused has filed pursis vide Exh.02 and has voluntarily pleaded guilty. I have framed a particular against the accused. The particular is read over and explained to the accused in marathi. The plea of the accused being voluntary and unconditional, I accept the same and hold the accused guilty of the offence U/sec. 285 of the Bharatiya Nagarik Suraksha Sanhita, 2023. Hence I hold him as a guilty.

I have heard the accused on the point of sentence. He has prayed for leniency on the ground that he is the only earning member of family. Considering the nature and gravity of the offence and the financial circumstances of the accused following order would meet the ends of justice. hence I proceed to pass the following order.

ORDER

The accused is hereby convicted U/sec. 275 of BNSS, on his own admission for the offence punishable U/sec. 285 of the Bharatiya Nagarik Suraksha Sanhita, 2023 and sentenced to pay fine of **Rs.-100/-** (Rs. One Hundred only) in default of payment of fine to suffer simple imprisonment for 8 (eight) days.
