No. 1. and Rs. 5,00,000/-, each be kept in fixed deposit in the name of Appli. No. 2 & 3, till they attain majority, with liberty to withdraw interest on fixed amount for their father, claimant No. 1 Sanjay. ③ claim petition is disposed off against N.A. 2 Ans 10, accordingly & as withdrawn against N.A. No. 1. ④ whole court fee be refunded in the name of the Appli. No. 1.
