This is an application moved by non-applicants No.3, 5 and 7 praying therein to set aside the ex-parte order dated 07.10.2025 passed below Exh.1 and to allow non-applicants No.3, 5 and 7 to file reply.

2] Read the application. It is submitted that since 07.10.2025 the matter was fixed for filing reply of the non-applicants. Non-applicant Nos.1, 2 and 4 appeared before Court and sought time to file

reply. But non-applicant Nos.3, 5 and 7 failed to appear before Court. Hence, order below Exh.1 was passed to proceed the matter ex-parte against non-applicant Nos.3, 5 and 7.

3] Vide instant application non-applicant Nos.3, 5 and 7 prayed to set aside ex-parte order. In the instant application non-applicant submitted that non-applicants had traveled out of station and therefore, they could not communicate to their counsel. Hence, reply could not be filed in time. Counsel for the applicant opposed the application by submitting that application is not tenable and liable to be rejected.

4] Read the application and say. Heard, Ld. counsels for both the parties. Perused the record. It is seen that matter is filed under Section 12 of Protection of Women against Domestic Violence Act. In order to decide the matter on merit and in the interest of justice it is necessary to give non-applicant No.3, 5 and 7 an opportunity to file their say. Hence, I pass the following order.
