ORDER

The accused has pleaded guilty in the present matter hence he needs to be convicted. I have explained him in vernacular language the consequences for pleading guilty. I am satisfied that accused has voluntarily pleaded guilty. The accused is heard on point of sentence. The accused submitted that he is poor and undertakes that he would not commit similar type of offence. The accused submitted that it is his first offence hence lenient view be taken by court and prayed to impose minimum fine. I am convinced that looking into the age of accused and his strata of society which he belongs minimum fine would meet the ends of justice. In the result, I am inclined to pass following order.

ORDER

1. Accused is convicted vide section 275 of the Bhartiya Nagrik Suraksha Sanhita for the offence punishable under section 185 of Motor Vehicles Act 1988, and is sentenced to pay fine of **Rs. 1000/- (Rs. One Thousand Only)** in default of payment of fine to suffer simple imprisonment for a period of 03 days.
2. The bail bonds of accused stand cancelled.
