COMMITTAL ORDER

(Passed on this 30th day of March, 2026)

01) After completion of the investigation in Crime.
No.263/2025 registered with Police Station, Sironcha, the



officer in-charge has filed charge sheet for the offences punishable under section 76, 74, 54, 296, 329(4), 115(2), r/w.3(5) of Bharatiya Nyaya Sanhita. The accused is present today. Advocate Shri. J. M. Kondagorla is representing the accused.

02) Perusal of police papers make it clear that, the offence is prima-facie made out. So cognizance of offence punishable u/s. 76, 74, 54, 296, 329(4), 115(2), r/w.3(5) of Bharatiya Nyaya Sanhita must be taken and process is required to be issued against the accused for the said offence.

03) In view of pursis below Exh.28 the copy of charge sheet, statements of witnesses and other documents are supplied to the accused as required by Sec. 230 of the Bharatiya Nagrik Suraksha Sanhita. Endorsement to that effect is made on Exh.1.

04) The offence punishable under section 76 of the Bharatiya Nyaya Sanhita is exclusively triable by the Hon'ble Court of Sessions as per Schedule I of Bharatiya Nagrik Suraksha Sanhita.

05) Present offence is exclusively triable by Hon'ble Sessions Court. Hence, It is necessary to commit the case to



the Hon'ble Court of Sessions, **Aheri**. Accordingly, I proceed to pass following order :-

ORDER

01) The case of accused namely **Salar Sayyad Husen** is hereby committed under section 232 (a) of the Bharatiya Nagarik Suraksha Sanhita-2023 to the Hon'ble Sessions Court, **Aheri**.

02) The record of the case, the documents and articles, if any, which are to be produced in the evidence be sent to the Hon'ble Court of Sessions, **Aheri**.

03) The Police Station Officer, Police Station - **Sironcha** be directed to produce muddemal property in Crime No.263/2025 in the Court of Hon'ble Sessions on or before **15/04/2026** positively.

04) Notify Public Prosecutor about the commitment of the case as per sec. 232(d) of B.N.S.S.-2023.
