This is an application under section VIII (2) of the Bombay Regulation Act, 1827 for issuing legal heirship certificate.

2. According to the applicants, applicant no.1 is the wife and applicant no.2 to 3 are the son and daughter of deceased Dhanuji Kanuji Tunkalwar. Said Dhanuji Kanuji Tunkalwar died on 12/07/1995 due to old age at Sonapur, Tq. Chamorshi, Dist.-Gadchiroli. The applicants are the legal heirs of deceased Dhanuji Kanuji Tunkalwar. The applicants have filed this application for heirship certificate for recording their names to movable and immovable property belonging to Dhanuji Kanuji Tunkalwar as legal heirs.

3. The applicant no.1 has lead her evidence by way of evidence affidavit (Exh.10) in support of her claim. Verified copy of death certificate (Exh.11) of deceased Dhanuji Kanuji Tunkalwar which shows that he died on 12/07/1995 at Sonapur, Tah. Chamorshi, Dist. Gadchiroli.

4. The proclamation (Exh.17) was published in daily newspaper Yuwarashtra Darshan dated 11/02/2026 inviting objection within 30 days but none has appeared and raised objection until now. Notice inviting objection was also affixed on the notice board of this court and Gram Panchayat Sonapur. No one has come forward with any objection. Perusal of heirship certificate (Exh.12) issued by Police Patil Sonapur and shows that the applicant are the legal heirs of deceased Dhanuji Kanuji Tunkalwar. Considering the documentary and oral evidence on record, I am satisfied that applicants are the legal heirs of deceased Dhanuji Kanuji Tunkalwar. Therefore, it is just and desirable to issue legal heirship certificate in favour of applicants. Therefore, I proceed to pass following order.

ORDER

- 1 The application is allowed.
- 2 Issue legal heirship certificate in the name of applicants formally recognizing that the applicant is the legal heirs of deceased Dhanuji Kanuji Tunkalwar on payment of requisite court fees.
