Judgment

The instant application is filed under section 503 of Bharatiya
Nagarik Suraksha Sanhita, 2023 for releasing two wheeler Hero H.F.
Deluxe bearing registration No. MH/33/U.-8436 Chassis
no.MBLHAR052H9K47849 and engine no.HA11EPH9K21257 seized in
Crime No. 26/2025 for the offence p/u/s 12(b), 11(f)(n) of Prevention of
Cruelty to Animal Act, registered at Police Station, Regdi.

2. It is the contention of the applicant that, said vehicle is registered in the name of her father namely Bhauji Sukaru Hichami who died on 08/04/2024. On 21/09/2025 Regdi Police have seized the said vehicle in crime no. 26/2025. The said vehicle is standing idle and unattended at Regdi Police Station. The said vehicle is required for her daily use. The applicant is ready to abide by any condition to be imposed by this court while releasing the vehicle.

3. IO filed no objection to the application. Ld. APP filed his say that, the investigation is in progress. Therefore, he prayed to reject the application.

4. Heard both sides. Perused the application and documents filed with it. The certificate issued by Sarpanch and Police Patil of Regdi shows that the applicant is the daughter of Bhauji Sukaru Hichami. No one has claimed the said vehicle except the applicant. If the said vehicle kept unused at the police station it will become junk. Considering the ratio laid down in **Sunderbhai Ambalal Desai Vs. State of Gujrat on 1 October,2022**, the application deserves to be allowed. Therefore, I proceed to pass following order.

ORDER

- 1 Application is allowed.
- 2 Two wheeler Hero H.F. Deluxe bearing registration No. MH/33/U.-8436 Chassis no.MBLHAR052H9K47849 and engine no.HA11EPH9K21257 seized in Crime No. 26/2025 be returned to applicant Ranjana Bhauji Hichami, till the conclusion of the trial on executing indemnity bond of 40,000/- (Rs. Fourty thousand Only) against the vehicle.
- 3 The applicant to undertake that she shall not sell, transfer or create any third party interest on the above vehicle and she

shall not change the nature of vehicle. The applicant to maintain and preserve vehicle in all respects. The applicant shall produce the vehicle in question as and when required and directed by the court and investigation officer. The applicant is further directed to undertake that she shall not use the vehicle in commission of any offence including the offence in which the vehicle was seized.

4 The I.O. is directed to prepare detail panchanama of the said vehicle, take photograph of the vehicle from four angle and release the above vehicle.

5 Prosecution is at liberty to approach this court for cancellation the supratnama bond in case of breach of condition by the applicant or anybody on behalf of the applicant.

6 The record and proceeding of this application be attached to the chargesheet in crime 26/2025.

7 The custody of the said vehicle is interim pending trial and subject to final order in the case.
