5. Particulars of the offence:-

Firstly on 15/11/2021 at 11:00 hours near Hetinagar on Purada to Kurkheda main public road, you drove the Two-wheeler vehicle bearing no. MH-40/A-7158 on a public way in a manner so rash or negligent as to endanger human life and thereby committed an offence punishable under Section 281 of the Bharatiya Nyaya Sanhita, 2023 (U/sec. 279 of the Indian Penal Code) and within my cognizance.

Secondly, on the same date, time and place, you above named accused was found transporting adulterated article of food i.e. 1) 320 pouch of scented Egal Hukka Shisha Tobacco having weight 200 gram each, 2) 110 pouch of scented Egal Hukka Shisha Tobacco having weight 400 gram each and 3) 57 pouch of scented Hola Hukka Shisha Tobacco having weight 200

gram each, in four wheeler Scorpio vehicle bearing registration no. MH-40/A-7158 as to make the said article noxious as food intending to sell the said article as food or knowing to be likely that the same would be sold as food and that you thereby committed an offence punishable under section 274 of the Bharatiya Nyaya Sanhita, 2023 (U/sec. 272 of the Indian Penal Code), and within my cognizance.

Thirdly, on the same date, time and place, you above named accused found transporing prohibited food i.e. 1) 320 pouch of scented Egal Hukka Shisha Tobacco having weight 200 gram each, 2) 110 pouch of scented Egal Hukka Shisha Tobacco having weight 400 gram each and 3) 57 pouch of scented Hola Hukka Shisha Tobacco having weight 200 gram each, which had been rendered noxious knowing that the same was noxious as food and thereby committed an offence punishable under section 275 of the Bharatiya Nyaya Sanhita, 2023 (U/sec. 273 of the Indian Penal Code), and within my cognizance.

Fourthly, on the same date, time and place, in disobedience of the order duly promulgated by public servant, was found transporting prohibited food i.e. 1) 320 pouch of scented Egal Hukka Shisha Tobacco having weight 200 gram each, 2) 110 pouch of scented Egal Hukka Shisha Tobacco having weight 400 gram each and 3) 57 pouch of scented Hola Hukka Shisha Tobacco having weight 200 gram each, in your possession for selling and storing unsafe in four wheeler vehicle bearing registration no. MH-40/A-7158 and thereby committed an offence punishable under section 223 of the Bharatiya Nyaya Sanhita, 2023 (U/sec. 188 of the Indian Penal Code), and within my cognizance.

Lastly, on the aforesaid date, time and place you drove your above said vehicle in speed and in a manner dangerous to the public, having regard to the circumstances and condition of the road and thereby
