**Common Order Below Exh.01 & Exh.15**

(Passed on 02.03.2026)

Application Exh.15 is filed by the legal heirs of the deceased applicant Renukabai Rambharose Rangari. As per application, applicant is died on 15.12.2025 and applicant no. 1 and 2 are her legal heirs. Hence, they prayed to permit them to be added as legal heirs of the deceased.

2. The say of the non-applicant was called. Non-applicant has filed say on the overleaf that application may be rejected. Heard Learned Advocate Shri. C.M. Janbandhu for the applicant and Learned Advocate Shri. A.P. Nakade for the non-applicants.

3. Perused the documents filed on Exh.16. On Exh.16, Death Certificate of the applicant Renukabai Rambharose Rangari issued by Grampanchayat Korramtola on dated 28.12.2025 shows that she is died on 15.12.2025 and applicant no. 1 and 2 by name Kamal Kishor Rangari and Kaushilya Rambharose Rangari are her legal heirs. The application to take her legal heirs of the deceased is filed within 90 days from the 15.12.2025. Hence, considering that original applicant Renukabai Rambharose Rangari

died on 15.12.2025, it is permitted to applicants to add them as legal heirs of the deceased. Hence, I pass following order:

**ORDER**

1. The application is allowed.
2. Applicant no. 1 Kamal Kishor Rangari and applicant no. 2 Kaushilya Rambharose Rangari are permitted to add them as the legal heirs of the deceased applicant Renukabei Rambharose Rangari who died on 15.12.2025.
3. The applicant no. 1 and 2 shall amend the application forthwith, to file amended copy of the application and evidence on next date 05.03.2025.
