1. This is an application for condonation of delay.
2. Perused the application. Heard learned advocate appearing for the applicant. It is submitted that order against Juvenile Justice Board should have been challenged within 30 days. However, the applicant is resident of Chhatisgarh and his family members are not educated. Therefore, they could not contact advocate and delay is caused.
3. Investigating officer filed say(Exhibit No.5) and opposed the application. It is submitted that reasons given are not satisfactory. Hence, application is rejected.
4. It appears that application of bail filed by Child In Conflict With Law was rejected. The applicant is resident

of Chhatisgarh. He is from poor background. It appears that he could not contact his advocate within period of limitation. I am satisfied that there was sufficient ground which prevented the applicant from filing the appeal within the period of limitation. Hence, I pass the following order.

ORDER

1. Cri. Misc. Appln. No. 11/2026 is allowed.
2. Delay is condoned.
3. Appeal be registered subject to removal of office objection if any.
