STATE OF MAH. VS. KAILASH THAKRE & ORS.

ORDER BELOW EXH.37.

(Passed on 16th October, 2024)

The applicant/accused No.1 by name **Kailash S/o Madhukar Thakre** by this application under Section 439 of the Code of Criminal Procedure prays for regular bail in Sessions Case No.95/2014 (Crime No.84/2012) registered with Tirora Police Station, District Gondia under Sections 395, 353, 186 and 201 of The Indian Penal Code and Section 4/25 of Arms Act.

2. Perused the application. No say is filed by Learned PP/APP and Investigating Officer from 19/09/2024.

3. From the contents of application, it reveals that, accused was initially released on regular bail on 18/09/2012 by passing order below Exh.1 in Crime No.84/2012. Then after, N.B.W. was issued against applicant/accused No.1, same was executed on 31/07/2024 and since 31/07/2024, applicant/accused No.1 is behind bar. He is ready to abide any condition, if so imposed on him and henceforth attend the Court regularly.

4. Heard Learned Advocate for applicant/accused No.1. Gone through the record. From the record, it reveals that, applicant/accused No.1 jumped out the conditions of regular bail. N.B.W. was issued agaisnt applicant/accused No.1 and since 31/07/2024, he is behind bar. From the record, it further reveals that, earlier regular bail application of applicant/accused No.1 was of Rs.30,000/-. Applicant/Accused No.1 has deposited amount of Rs.15,000/- vide pursis at Exh.38 on 04/10/2024.

5. After going through the record, I found force in the contents of application that applicant/accused No.1 is resident of Mahagaon, District Yavatmal. He could not attend the dates. From the record, it reveals that, on 04/10/2024, applicant/accused No.1 deposited amount of Rs.15,000/- and prayed for fresh bail. No doubt, applicant/accused No.1 has misused his liberty. However, fact remains that he was on regular bail. Hence, I am of the view that, it would be just, proper and judicious to release the applicant/accused No.1 on regular bail by imposing some conditions on him, so that he could not be in a position to misuse the liberty. Hence, I proceed to pass following order.

ORDER

1. The application (Exh.37) for regular bail is hereby allowed.
2. The applicant/accused No.1 by name **Kailash S/o Madhukar Thakre** be released on regular bail on executing PR bond of Rs.30,000/- and solvent surety of like amount in Crime No.84/2012 (Sessions Case No.95/2014) registered with Tirora Police Station, District Gondia under

Sections 395, 353, 186 and 201 of The Indian Penal Code and Section 4/25 of Arms Act, on the following conditions:

- (a) Applicant/Accused No.1 is directed to attend the Court regularly henceforth and not to misuse his liberty in any manner.
