State, PSO, Ramnagar -Vs- Pravin Mutkure

ORDER BELOW EXH.28.

(Passed on this 14th day of September, 2022)

This is an application filed by applicant/accused **Ankaj Sohanlal Rane @ Rana** for grant of bail u/s 439 of Cr.P.C. The applicant/accused has been arrested on 07/06/2022 by Police Station, Ramnagar in Crime No. 139/2022 for alleged offence punishable under Sec. 307, 323, 504, 506, 143, 144, 147, 148, 149 of IPC and Sec.135 of Maharashtra Police Act. Charge-sheet has been filed.

2] Brief facts of the prosecution case is as under:

That, on 06/06/2022 at about 9.30 p.m. the co-accused along with the applicant is alleged to have assaulted the informant Adarsh Babulal Bhagat by kicks and fist. The injured Sanket ran away. At that time the Pravin and other co-accused ran after Sanket and caught him. While Pravin, co-accused Atul and Vaibhav held Sanket, applicant Ankaj inflicted stab injury to Sanket by a knife.

3] Learned Advocate for the applicant Shri Shyamkuwar submits that the applicant is behind bar since more than 6 months. He is of tender age. Investigation is over and charge-sheet is filed. Co-accused have been released on

bail. The conclusion of trial would take some time. There are no criminal antecedents of the applicant. Applicant is local resident of Gondia. He has prayed for grant of bail.

4] I.O. has filed reply at Exh. 31 and opposed the application on the ground that the applicant is the main accused who inflicted knife blows with intention to kill him. Prima facie case is made out against the applicant. The applicant conspired with other accused and committed the crime. The incriminating articles sent for for C.A. He may threaten or influence the witnesses. He has prayed for rejection of the application.

5] Ld. APP Shri. Pardhi has filed reply and opposed the application on the ground that the charges of serious. Prima facie case is made out in the charge-sheet. Looking to the seriousness of the crime, bail application may be rejected. He has prayed for rejection of the application.

6] Perused the copy of the charge-sheet. As per the evidence on record the applicant is alleged to have assaulted the injured by knife. Investigation is over and charge-sheet is filed. The accused is of tender age of 22 years. No criminal antecedents are reported. There are remote chances of aggravation of the offence. Accused is behind bar since 6

months. Trial would take some time to conclude. Hence, I pass the following order.

ORDER

- 1] Application [Exh.28] is allowed.
- 2] The applicant/accused **Ankaj Sohanlal Rane @ Rane** be released on his executing PR bond of Rs.25,000/- and furnish one surety of Rs.15,000/- on the following conditions;
 - i] The applicant shall not threaten or influence the witnesses.
 - ii] The applicant shall attend the trial regularly.
- 3] Application is disposed of.
