**ORDER BELOW EXH. 01**  
**(Passed on 11.03.2026)**

The complainant has filed the present complaint under Sections 504 and 506 read with Section 34 of the Indian Penal Code, 1860. By order dated 05.08.2023, process was issued against Accused Nos. 1 to 7 for the offences punishable under Sections 504 and 506 read with Section 34 of the Indian Penal Code, 1860. Pursuant to the issuance of summons, Accused Nos. 1 to 7 appeared before the Court. Thereafter, the substance of accusation was explained and recorded on 07.12.2023. Subsequently, the matter was posted for recording the evidence of the complainant. However, the complainant remained absent and failed to adduce his evidence. Despite granting sufficient opportunities, the complainant has not remained present before the Court to prosecute the matter. This conduct clearly indicates total disregard and lack of interest on the part of the complainant in prosecuting the complaint. Therefore, there remains no alternative but to dismiss the complaint due to the non-appearance of the complainant. Hence, the following order

**ORDER**

1. The complaint filed under Sections 504 and 506 read with Section 34 of the Indian Penal Code, 1860 is dismissed under Section 256 of the Code of Criminal Procedure, 1973.
2. Accused Nos. 1 to 7 are acquitted of the offences punishable under Sections 504 and 506 read with Section 34 of the Indian Penal Code, 1860 under Section 256 of the Code of Criminal Procedure, 1973.
3. The bail bonds, if any, stand cancelled and the sureties are discharged.
4. The matter stands disposed of accordingly.
