The applicant filed application for releasing the PASSION PRO SELF CAST WHEELS two wheeler vehicle bearing No. MH-35-AB-3909 Chassis No. MBLHA10BJFHD35102, Engine No. HA10ETFHD35199 on supratnama.

2. The aforesaid vehicle has been seized by P.S.O. Arjuni/Morgaon in crime no. 110/2026 for the offence punishable under section 303(2) of B. N. S. Act.

3. The learned APP and investigating officer filed their say. They have no objection to release the said vehicle by imposing terms and conditions.

4. Heard both the parties. Perused the application & say of APP and I.O. Also perused verified copy of registration certificate of vehicle and verified copy of adhar card of applicant.

5. After perused all the documents it appears that the applicant Chandrashekhar Jagan Shendre is the owner of said vehicle bearing

Regstraiton No. No. MH-35-AB-3909. In the facts and circumstances, the applicant prima facie appears to be the owner of the said vehicle which is seized by P.S.O. Arjuni/Morgaon in crime no. 110/2026. In such circumstance no purpose would be served by keeping the said vehicle idle at Police Station. This would also cause its deterioration. In the facts and circumstance, I am inclined to release the said vehicle bearing No. MH-35-AB-3909 and give its interim custody in favour of the applicant, hence following order is passed.

Order

1. Application is allowed.
2. The concerned Police Inspector, P. S. Arjuni/Morgaon to give the custody of PASSION PRO SELF CAST WHEELS two wheeler vehicle bearing No. MH-35-AB-3909 Chassis No. MBLHA10BJFHD35102, Engine No. HA10ETFHD35199 seized in crime no. 110/2026 to the applicant Chandrashekhar Jagan Shendre on his executing indemnity bond of Rs. 50,000/-.
3. The concerned Police Inspector, P. S. Arjuni/Morgaon is directed to verify the insurance policy and released the vehicle after duly verifying the insurance papers.
4. Applicant shall not change the nature of said vehicle and shall not create any third party interest in it and shall produce it in the court as and when directed.

5. The applicant is directed to produce the said vehicle as & when required.
6. The I.O. of the present crime is hereby directed to draw detailed panchanama of the said vehicle, verify chassis number & engine number of the vehicle & capture photograph of the same before handing it to the applicant.
7. Copy of this order be kept along with remand papers in the Police Station, Arjuni/Morgaon of Cri. No. 110/2026.
