ORDER BELOW EXH. 10

1. The plaintiff moved present application and prayed for status-quo directing defendant not to interfere the possession of plaintiff over suit property Gat No. 258 area 0.06 HR.
2. The defendant filed say and submitted that in RCS No. 57/2021 defendant already got the TI against present plaintiffs. It is nothing but attempt to counter blast the previous suit. Therefore he prayed for rejection of application.
3. Heard both the Ld. Advocates. I have gone through the record. It reflects that the present suit appears cross suit to the R.C.S. No. 57/2021 pending before this court in which TI has been granted against present plaintiffs. Admittedly plaintiffs and defendants are owners of area 0.06 HR and 0.56 HR respectively out of Gat No. 258. It is contention of plaintiffs that defendants are disturbing their possession over suit property on the basis of TI order in cross suit.
4. Plaintiffs and defendants are appear adjacent owners. Today defendants appear and prayed for time to file reply over TI application. Considering the contention of plaintiff, at this juncture it is just to direct both parties to maintain status-quo in respect of suit property. Hence following order.

ORDER

1. The application is partly allowed.
2. Defendants are directed to maintain status-quo in respect of suit property till filing their reply.
