Further Examination in Chief of Witness by Advocate Shri. U. S. Jagdale, for the Complainant :-

8. Witness is present today. He on solemn affirmation admitted his signature on the affidavit and also admitted that the contents of evidence affidavit are true and correct. Hence, evidence on affidavit is taken on record.

Cross examination by Advocate Mrs. S. H. Danke, for the Respondents :-

09. I am working as a Vehicle Examiner since 1999. I joined my duties in the year 1999, in the Vasai Depot. Since then, I am working in the same depot. Temporarily, I was transferred to Murbad Depot for One Year, in the year 2008-09. Thereafter, I again working in Vasai Depot. Earlier, there were Three posts of Vehicle Examiner in Vasai Depot. Now there are Two posts. It is not correct to say that, One post of Vehicle examiner was extra in Vasai depot. I was transferred from Vasai to Divisional Workshop, Palghar.

10. I know that only one post is at Palghar Divisional Workshop Depot as a Vehicle Examiner. It is not correct to say that, more amount of work is there in the Palghar Depot than the Vasai Depot. It is not correct to say that, I am deposing false that as the Palghar Depot is a Divisional Workshop, there is more work than Vasai Depot, but I am deposing false.

11. It is not correct to say that, there was necessity of one vehicle examiner, therefore I was transferred to Palghar Workshop. I

have not filed any document to show that there was no necessity of one post of vehicle examiner at Palghar Depot. It is correct to say that, one Mr. Dipak Thorat was working with me at Vasai Depot as a vehicle examiner. Mr. Thorat was junior to me. Mr. Pilote was senior to me. He was working as vehicle examiner at Vasai Depot. It is correct to say that, Mr. Dipak Thorat was transferred from Vasai depot. It is correct to say that, due to illness Mr. Thorat did not join Palghar Workshop and he requested for VRS.

12. It is correct to say that, I was not transferred on punishment. I am not well aware about the circular dated 16-11-1989 as well as Circular dated 04-12-2015, and also Circular No. 5/2014. I do not know about the Clause 123 of Settlement for the year 2000 to 2004.

13. It is not correct to say that, I have not filed any document / Medical Certificates to show my illness and illness of my family members on the record. It is not correct to say that, I have filed false complaint and also filed false evidence affidavit. It is not correct to say that, the transfer order issued by the Respondents, is correct.
