

**Order below Exh.23 in Sessions Case No.110 of 2022**  
**(State of Maharashtra V/s. Amol Dattu Patil & Ors.)**  
**(CNR No. MHJG-01000-963-2022)**

This is an application under Section 439 of the Code of Criminal Procedure filed by the applicants/accused nos.2 **Lakhan Ramesh Gaikwad** and no.4 **Jyotibai Gopi Patil** for releasing them on bail in Crime No. 139 of 2022 of Parola police station, Dist. Jalgaon for the offences punishable under Sections 397, 395, 394, 120(B) and 323 r/w Section 34 of the Indian Penal Code.

02) The accused submitted that the applicants/accused are innocent, they are the Karta of their respective families if they are kept behind bars then their family member will face starvation, they will abide all the conditions imposed by the Court, they are not habitual offenders. With all these reasons the accused have requested for bail.

03) A.P.P. has filed reply on the overleaf of the application and has strongly opposed the application on the ground that before this applicants have not complied with the conditions of the bail and again they will abscond. With all these reasons, the application is opposed.

04) On perusal of record it appears that the accused remained absent though case was pending for framing of charge since 2022. Therefore, NBW was issued against them. Both the accused are kept in jail in execution of NBW. The case was for

framing of charge. Charge is framed on 18/09/2025 against the accused. Therefore, the main purpose to proceed with the case is completed. The allegations against the accused are under Sections 397, 395, 394, 120(B) and 323 r/w Section 34 of the Indian Penal Code. The accused submitted that they will regularly attend the trial. Therefore, considering the nature of the offence, submission from the side of accused, I would like to give one opportunity to the accused to be released on bail. Accordingly, following order is passed -

### **ORDER**

- 1) The application is allowed.
- 2) The applicants/accused nos.2 **Lakhan Ramesh Gaikwad** and no.4 **Jyotibai Gopi Patil** be released on bail on their executing P.R. Bond of Rs.15,000/- (Rs. Fifteen Thousands only) each with one local solvent surety in the like amount, in Crime No. 139 of 2022 of Parola police station, Dist. Jalgaon for the offences punishable under Sections 397, 395, 394, 120(B) and 323 r/w Section 34 of the Indian Penal Code.
- 3) The accused are directed to remain present on each and every date of hearing before the Court.
