PW-1 Statement of ASI Parjinder Singh No.409/FGS, posted at PS Bassi Pathana, District FGS. On SA

On 18.07.2021, I was posted at PS FGS . On that day, I along with police party HC Surjit singh and PHG Bhupinder Singh were present and patrolling at T-Point Jyoti Sarop Mode FGS on a private vehicles along with printer and laptop. At about 7.25 PM I received secret information that Rana son of Bant Singh resident of village Talania who is habitual of bringing cheap liquour from Chandigarh and supplies the same. Today also is coming on his motor cycle to supply liquour to Davinder Singh @ Faouji son of Baldev Singh resident of near Singhi Hospital Bhati road Sirhind is coming towards Ropar Bus Stand Sirhind side and liquour can be recovered from him. As the information was reliable I scribed the ruqa Ex. P1 and same was sent to PHG Bhupinder for registration o FIR. The endorsment of FIR is Ex. P2 on which I identify signatures of SI Baldev Singh. The copy of FIR is Ex. P3. Then I along with police party laid down a naka near Chungi No.4 Sirhind. While we were going towards Chungi No.4 Excise Inspector kulwinder singh were joined in the police party near Aam Khas Bagh Sirhind . And we started checking vehicles then at about 8.30 PM one person was coming seen on motor cycle from Jyoti Saroop Mode FGS. The said motor cycle bearing PB-23U-1597 make Bajaj CT-100 was stopped and the accused disclosed his name as Davinder singh @ Fauji son of Baldev Singh. The said person was having one plastic bag on fuel tank of motor cycle and the plastic bag was tied at the top. On checking the said plastic bag 24 bottles of liquour make 777 Oak vat whisky for sale in Chandigarh was recovered.

The accused failed to produce any license or permit for keeing the said liquor. Then I arranged one plastic cane at the spot and one quarter and all the 24 bottles were put into the plastic cane and thereafter a sample nip of 180 ml was separated and remaining liquor was measured as 23-3/4

bottles. After measurement the said liquor i.e. 23 -3/4 bottles, plastic bag containing empty 24 bottles along with corks and sample nip as well as plastic can containing liquor were sealed by me with seal impression PS.

Sample seal Ex.P4 was separately prepared and also filled form No.M29 Ex. PX and seal was handed over to Excise Inspector Kulwinder Singh after its use. The recovered liquor containing in plastic can, sample nip and sample chit were taken into police possession vide memo Ex.P5 which was witnessed by Excise Inspector Kulwinder and HC Surjit singh and attested by me. Then I took the said motor cycle into possession vide memo Ex. P6. Then I prepared the rough site plan Ex. P7. The accused was arrested vide arrest memo Ex.P8. His personal search memo Ex.P9 was prepared by me.then I recorded the statement of witnesses deposited the case property with MHC PS FGS and accused was put into lockup PS FGS. On 22.07.2021 I moved an application Ex. P10 before registering authority FGS for proving the RC recovered motor cycle and I obtain the screen report and recorded the statement of Amarjit singh RC Dealing Clerk RTA FGS. On 14.10.2021 the accused Rana Singh son of Bant Singh was produced before me by Surjit singh son of Gurcharan Singh resident of village Talaria along with bail orders from District & Sessions Judge FGS. AS per the orders the accused Rana singh were joined in the investigation and was arrested vide memo Ex. P11 and his personal search was conducted vide memo Ex. P12. The chemical report is Ex. P13. During investigation the fact came into light that accused Davinder Singh had already taken the delivery of recovered liquor from accused Rana Singh before he was apprehended by the police. During investigation I collected the relevant record and recorded the statement of relevant witnesses.

After completion of investigation, challan was prepared against accused Davinder Singh and Rana Singh by Inspector Kuljinder singh whose signatures I identified on the report u/s 173 CrPC. Accused Rana

Singh is present in the Court and I identify him. I have also seen the plastic can today in the Court which is MO1 and plastic bag containing empty bottles MO2.

I do not remember the exact date of my posting/duration at PS FGS. Voluntary I remained there one year. During that period i have worked with three SHO at PS FGS. On 18.07.2021 Sh., Kuljinder singh was posted at PS FGS. On 18.07.2021 I was having my own car NO. PB-23Q-9186 (swift Dezire) along with HC Surjit Singh and PHG Bhupinder singh at about 7.00 PM moved from PS FGS. I have entered the relevant entry in the rojnamcha PS FGS. We have not intercepted any private vehicle on 18.07.2021. Earlier the police party was stopped at T-Point Jyoti Saroop Chownk FGS at about 20 minutes but we have not intercepted or checking at T-Point Jyoti Saroop Chownk. The informer met me at T-Point at about 7.25 PM. Then before reaching at the spot at told by informer,the ruqa carrier was sent PHG Bhupinder Singh to PS FGS for the registration of case against accused persons u/s 61/1/14 Excise Act. Excise Inspector Kuljinder singh joined the police party at T-point Aam Khas Bagh we have not called the said Excise Inspector. Voluntary he suddenly met us and he was having his own settled car but I do not remember the registration number of said car. He joined us at about 8.15 PM. The distance between Jyoti Saroop Chownk T-Point Aam Khas Bagh Sirhind is about half km and it took 10 minutes to the police party to reach police party at Aam khas Bagh Sirhind. Then at about 8.15 Pm laid down police naka at chungi No.4 Sirhind

and have also checked and inspected some vehicles but I have not prepared any list of said vehicles which were intercepted by police at police naka Chungi No.4 Sirhind. I do not remember the name and detail of whereabouts of the driver/ owners of vehicles intercepted by the police at Chungi No.4 Sirhind. The accused Davinder Singh was coming from Jyoti Saroop on motor cycle at about 8.30 Pm. I or police official were not aware regarding the identification of accused Davinder Singh. When the motor cycle was intercepted then he disclosed his identity. It is wrong to suggest that the accused was not intercepted at Chungi No.4 on 18.07.2021. it is wrong to suggest that it is not possible to carry 24 bottles on the fuel tank of motor cycle. It is wrong to suggest that as per the dimensions of fuel tank of CT-100 motor cycle it is not possible to carry 24 bottles by a single person who is driving the same. It is wrong to suggest that the police have planted the false case against accused Davinder Singh and Rana Singh. The accused Davinder Singh was alone along with motor cycle. It is wrong to suggest that police have registered a false case under the political pressure of local MLA as accused Davinder Singh and Rana Singh were actively participated in the opposite party of local MLA. It is wrong to suggest that no recovered has been effected from the accused. It is wrong to suggest that the alleged recovery is commonly available in the local area. Police party remained at the spot at 10.15 Pm. It is wrong to suggest that the police have completed all formaility while sitting at police station. It is correct that at about 9.00 Pm all shops are closed. Voluntary police have taken the light from the plug attached outside the closed shop of Channa Tyres Sirhind. It is wrong to suggest that as there is no electricity arrangement so it is not possible to scribe the statement on a laptop. It is wrong to suggest that police have not compelled the

mandatory provisions. It is wrong to suggest that police have implicated the accused persons in false case. On 18.07.2021 police party have not met with the accused. Case property was deposited before MHC FGS at about 10.30 Pm and only accused Davinder singh was produced before Illaqa Magistrate and sent to judicial custody. It is correct that the police party have not moved any application before the court to seek his arrest warrant for the investigation of present case. The accused Davinder singh have not mentioned any statement regarding involment of accused Rana Singh in the present case. Voluntary the informer has mentioned the name of acused Rana Singh but accused Rana Singh was not present at the spot. It is wrong to suggest that police have falsely implicated the accused Rana Singh. No recovery was effected from the accused Rana Singh. Accused Rana Singh was formally arrested in the present case on 14.10.2021. voluntary he was having anticipatry bail granted by Ld. Session Judge FGS. It is wrong to suggest that I am deposing falsely.

Thus, the complainant has prima facie filed the present complaint within period of limitation and the complaint is within the jurisdiction of the Court. On the basis of documents placed on record, let summons be issued to accused on filing PF/ RC returnable on 07.12.2022. The copy of complaint, relevant documents and list of witnesses be sent along with the summons. If the service is not effected by any of above means, affixation be done as per section 65 of Cr.P.C.

Steps be taken within 10 days from today.
