Today accused No.1 Kanhaiyya Tulashiram Thorat, accused No.2 Pankaj Bajirao Dhatrak, accused No.3 Amol Vijay Gavande, accused No.4 Deepak Prakash Shinde, accused No.5 Bhushan @ Sonu Santosh Sarag, accused No.6 Jayesh @ Bobby Manohar Dhatrak and accused No.7 Mohini Pankaj Dhatrak and their advocates present. The accused are alleged to have committed an offence punishable under **Sections 109(1), 119(2), 189(2), 191(2) (3), 190, 125, 352, 351(2)(3), 238 of Bharatiya Nyaya Sanhita, 2023 and Section 37(1),(3)/135 of Maharashtra Police Act 1951.**

2. The offence punishable under **Section 109(1), 119(2) of the Bharatiya Nyaya Sanhita, 2023** is exclusively triable by the Hon'ble Court of Sessions. The copies of police report and other documents as specified in **Section 230 (or Section 231) of Bharatiya Nagarik Suraksha Sanhita, 2023** has been supplied to accused. The accused are represented by their lawyer. The accused are asked whether they are required free legal aid advocate before Hon'ble Court of Sessions. They desires to make their own arrangement for their defense lawyer in the Hon'ble Sessions Court. The Hon'ble Sessions Court will have to be intimated accordingly. The case will have to be committed to the Hon'ble Sessions Court. Hence, the order.

ORDER

1. The case be committed to the Hon'ble Court of Sessions.
2. The accused 1 to 7 are directed to appear before the Hon'ble Court of Sessions on **07/08/2026**.
3. The record of the case, the documents and articles, which are to be produced in evidence, shall be sent to the Hon'ble Court of Sessions.
4. The Police Station Officer of concern police station be directed to produce *muddemal* property in the Hon'ble Court of Sessions on or before **07/08/2026** positively.
5. The Public Prosecutor shall be notified of the commitment of the case to the Hon'ble Court of Sessions.
