ORDER BELOW EXH.01

The applicant has filed this application under Section 503 of Bharatiya Nagarik Suraksha Sanhita,2023 for releasing his seized vehicle CBZ motorcycle having registration No. MH-21-M-855 seized by police station Kadim Jalna in connection with Crime No.324/2025.

02. Read the application and say given by Ld. App and I.O.

03. It is contended by the applicant that, he is owner and possessor of the above mentioned vehicle seized by police station Kadim Jalna. Further, the said vehicle is standing in the premises of the police station, as such the same may be damaged. Hence, he prayed for release of the same on supratnama.

04. Learned A.P.P. and the Investigating Officer have filed their say and thereby strongly objected to release said vehicle on the count that, it might be used for commission of similar offence again.

05. The Hon'ble Apex Court, in the case of ***Sundarbhai Desai Vs. State of Gujrat***, held that, property seized by Police in connection with an offence should be released as early as possible. Perusal of the record shows that, the applicant has filed copy of FIR, registration certificate and Aadhar card. On perusal of the same it appears that, the above said vehicle is registered in the name of applicant. If the said vehicle is kept at one place for long period of time, it would be rusted and applicant would suffer loss. Therefore, in my opinion it would be proper to return said vehicle to the applicant on supratnama by putting certain conditions. In the result, I pass the following order :-

Order

1. Application is allowed.
2. The P S.O., police station Kadima Jalna is directed to release the above referred CBZ motorcycle having registration No. MH-21-M-855, Engine No.07CBMM06645 and Chassis no.07CBMC06812 seized in Cri. No.324/2025 on supratnama in favour of the applicant Krushna Rajesh Mantri.
3. The applicant shall execute the bond of Rs.1,00,000/- (Rupees One Lac only) with following conditions in the bond.
 - a. The applicant shall not alienate or transfer the said vehicle to anybody without permission of the Court.
 - b. The applicant shall not change the nature of the said vehicle in any manner.
 - c. The applicant shall produce the said vehicle before this Court, Appellate Court, Revisional Court and other competent Court as and when ordered.
 - d. The applicant shall not use the above referred vehicle against the provisions of law.
4. The Kadima Jalna, Police Station is directed to prepare the panchanama of handing over of the said vehicle and take photographs of the same and submit the same in the Court along with charge-sheet.
5. Supratnama bond shall be submitted before the P.S.O. Kadima Jalna, Police Station.
