This is an application for grant of Heir-ship Certificate under Bombay Regulation Act 1827.

2] According to the applicants, Applicant No.1 being husband and applicant No.2 & 3 are children of deceased Farhin Shaikh Alim, who died on 04/02/2026. Therefore, applicants are only legal heirs of deceased Farhin Shaikh Alim. The applicant required heir-ship certificate for recording their names in various Government offices as well as Semi Government Office. Hence, this application for grant of heir-ship certificate.

3] After filing of application, the public notice was issued in respect of heirship. It was duly published in the daily newspaper 'Jagmitra' dated 21/03/2026. In response to said public notice, no one appeared or filed objection to the claim of heir-ship of applicants.

4] In support of their claim, applicant No.2 Mo. Alim Mo. Salim Gous filed affidavit of examination-in-chief at Exh.8. He has categorically stated that they are only legal heirs of deceased Farhin Shaikh Alim. The applicants have also filed on record, verified copy of death certificate of deceased Farhin Shaikh Alim at Exh.10, verified copies of Adhar cards of the applicant No.1 & 2 at Exh.11 & 12, verified copy of birth certificate of applicant No.3 at Exh.13, heirship certificate issued by Nagarsevak, Ambad in the name of applicants at Exh.14. Applicants have closed their evidence vide Pursis at Exh.15.

5] After considering the pleading, evidence of applicant, documents on record and submission of learned counsel for the applicants, this Court is of the opinion that issuance of heir-ship certificate is merely formal recognition as an heir of deceased. It appears from record that applicants are only legal heirs of deceased Farhin Shaikh Alim. Admittedly, names of the competent legal heirs ought to be recorded in the official record and revenue record. There is no denial to the rights of applicants. All the documents and evidence before Court is sufficient to issue heir-ship certificate in the name of applicant being heir. Hence, following order.

::ORDER::

- 1] The application is allowed.
- 2] Issue Heir-ship Certificate in the name of Applicant No.1 Mo. Alim Mo. Salim Gous, applicant No.2 Alisha Shaikh Alim, applicant No.3 Fabiha Shaikh Alim declaring them to be recognized heir of deceased Farhin Shaikh Alim on depositing requisite Court fee Stamp as per rules.
