**Order below Exh. 1**

This is an application for grant of Heir-ship Certificate under Bombay Regulation Act 1827.

2] According to the applicants, Applicant No.1 being husband, applicant No.2 to 6 are being sons and daughter of deceased Aminabi Rahimoddin Patel, who died on 02/05/2021. Therefore, applicants are only legal heirs of deceased Aminabi Rahimoddin Patel. The applicant required heir-ship certificate for recording their names in various Government offices as well as Semi Government Office. Hence, this application for grant of heir-ship certificate.

3] After filing of application, the public notice was issued in respect of heirship. It was duly published in the daily newspaper 'Punyanagri' dated 18/01/2026. In response to said public notice, no one appeared or filed objection to the claim of heir-ship of applicants.

4] In support of their claim, applicant No.1 Rahimoddin Yusuf Patel filed affidavit of examination-in-chief at Exh.8. He has categorically stated that they are only legal heirs of deceased Aminabi Rahimoddin Patel. The applicants have also filed on record, verified copy of death certificate of deceased Aminabi Rahimoddin Patel at Exh.11, heirship certificate issued by grampanchayat Shahagad in the name of applicants at Exh.12, verified copies of Adhar cards of the applicants at Exh.13 to 18 respectively. Applicants have closed their evidence vide Pursis at Exh.19.

5] After considering the pleading, evidence of applicant, documents on record and submission of learned counsel for the applicants, this Court is of the opinion that issuance of heir-ship certificate is merely formal recognition as an heir of deceased. It appears from record that applicants are only legal heirs of deceased Aminabi Rahimoddin Patel. Admittedly, names of the competent legal heirs ought to be recorded in the official record and revenue record. There is no denial to the rights of applicants. All the documents and evidence before Court is sufficient to issue heir-ship certificate in the name of applicant being heir. Hence, following order.

**::ORDER::**

- 1] The application is allowed.
- 2] Issue Heir-ship Certificate in the name of Applicant No.1 Rahimoddin Yusuf Patel, applicant No.2 Mujjamil Rahimoddin Patel applicant No.3 Mudassir Rahim Patel, applicant No.4 Shaikh Minhaj Shaikh Jabbar, applicant No.5 Asema Shahebaj Momin, applicant No.6 Farhin Nehal Ahemad Momin declaring them to be recognized heir of deceased Aminabi Rahimoddin Patel on depositing requisite Court fee Stamp as per rules.
