**Cri.M.A. No. 30/2026**  
**(Manda Vs. State of Maharashtra)**

**ORDER BELOW EXH.1**

(Decided on 24.03.2026)

Present application is filed by Manda Appasaheb Sherkar, under **Section 503 of Bharatiya Nagarik Suraksha Sanhita**, for interim custody of vehicle as well as trolley(trailer) seized in **Cr.No.581/2025** registered at Bhokardan police station. Seized tractor bears following description:-

(Hereinafter referred as 'Said Vehicle')

2] It is contention of the applicant that, applicant is in need of said vehicle for her daily use. Without said vehicle she is suffering from irreparable loss. If said vehicle is kept in police station without use then its condition will deteriorate. Said vehicle is not in need for further investigation. Hence, she prayed to handover interim custody of said vehicle.

3] Say of A.P.P. and I.O. was called out. A.P.P. filed his say that, if property is returned to the applicant then she will again use the said property for illegal purpose. Investigation is yet to be completed. Therefore, he prayed to reject the application. I.O. filed his say on same footing at Exh.4.

4] Record reflects that the trolley seized in the present Cr.no.581/2025 is not registered with the respective authority. Along with

Exh.2 the applicant produced one receipt showing the purchase of trolley in the name of the applicant. Therefore, to verify the said bill the notice was issued to I.O. Accordingly, I.O. filed his report at Exh.5 that, the applicant has purchased the said trolley from the vendor mentioned in receipt filed along with Exh.3.

5] Registration Certificate of the tractor produced at Exh.6 shows that the said tractor is registered in the name of applicant. As on today except the applicant no one claimed the tractor as well as trailer before this court. Report filed by I.O. at Exh.5, registration certificate at Exh.6 and receipt produced along with Exh. 3 further substantiate the claim of the applicant as a rightful possessor of the tractor as well as trolley(trailer).

6] Hon'ble Supreme Court laid down the ratio in ***Sunderbhai Ambalal Dessai v. State of Gujarat(2002) 10 SCC 283*** 'Owner of the article would not suffer because of its remaining unused or by its misappropriation. It is also laid down that before handing over possession of the article proper panchanama is to be prepared.'

7] Regarding non registration of the said trailer I would like to mention here the principle laid down by Hon'ble Bombay High Court in the case of **Parmeshwar Dudhe Vs. The State of Maharashtra Cri.Writ Petition no.841/2019**. In the said case the seized tractor was not registered while handing over the custody of said unregistered tractor Hon'ble Bombay High Court held that, "*If such is the state of affairs, when the prosecution itself is alleging that is the owner of the tractor which has been seized, it can very well be return to him instead of allowing it to be rusted further in the premises of the police station. Even the prosecutor was unable to reply as to what the prosecution would now do with the tractor if it was not to be returned to the petitioner. It is under such a circumstances that without getting swayed away by the allegations and*

*counter allegations about manipulation in respect of the chasis number and the engine number one will have to permit it to be returned to the petitioner, of course subject to suitable conditions so as to enable him to convert it into road worthy condition so that thereafter it can be duly registered and insured.”* In the said case Hon’ble Bombay High Court handed over the interim custody of tractor on the following conditions, “He undertakes to not to use the tractor unless and until it is duly insured and registered under the Motor Vehicles Act. Secondly, not to use it except for agricultural operations. Thirdly, execute personal bond.”

8] As mentioned above in the present case trolley(trailer) is an unregistered vehicle. Applicant furnishes an affidavit at Exh.8 that he will get the said trolley registered once released. No one except applicant claimed the said trolley(trailer). Therefore, considering ratio laid down by Hon’ble Bombay High Court in the case of **Parmeshwar (supra)**, report filed by I.O. at Exh.5 and affidavit furnished at Exh.8 by imposing stringent conditions upon the applicant trolley(trailer) also needs to be released on the basis of interim custody. Accordingly, I pass following order –

### **ORDER**

1. Application is allowed.
2. I.O. from Bhokardan police station is directed to take indemnity bond for the amount of Rs.8,00,000/- in lieu of said tractor as well as trolley(trailer) from the applicant.
3. The I.O. from Bhokardan police station is hereby directed to handover the interim custody of seized Tractor bearing no.MH-21-CA-9064 and Trolley(trailer) to the applicant by making detailed panchanama of the said vehicle by taking photographs, identification of the applicant and on the following conditions :
  - a. He shall not alienate, transfer or change the nature of said vehicle and trolley(trailer) till final disposal of the Cr.no.581/2025.

- b. He shall produce said vehicle as well as trolley(trailer) as and when required by the Court.
  - c. Applicant to get registered the trolley(trailer) as per procedure prescribed in Motor Vehicles Act from the competent authority within one month from the date of this order.
  - d. After getting registration done of the said trolley(trailer) applicant to report about the said registration to I.O. in the Cr.no.581/2025.
  - e. Till getting registration of the trolley(trailer) done from the competent authority applicant will not use or will not allow to use anybody on his behalf the trolley(trailer) for any purpose.
4. I.O. from Bhokardan police station is further directed to submit the detailed Panchanama as well as compliance report of above mentioned conditions before this court along with charge-sheet.
