Cross-examination for respondent No. 1 :

2] Respondent No. 1 and Advocate absent when called, hence, no cross.

Cross-examination for respondent No. 2 :

Cross-examination by Smt. U.J. Mairal, learned advocate for respondent No. 3 :

4] I have not produced ration card. I am resident of Kanholibara. My in laws were residing with me at the time of accident. My husband was B.Sc. Agricultural. He was only son of his parents. He has one sister. His birth date is 07/06/1994. I have not produced document of his qualification. I have not produced document of ITR. On the date of accident my husband was going by Bolero Pickup with black gram (kala chana). I have not produced document to show that Bolero was dis-repaired and not working. Accident took place on 6/4/23 at around 9:15 p.m. There were around four occupants in the Bolero. Their names are Ganesh Lidbe, Mahadeo Lidbe, Suraj Sahare, and Ujwal Gawhale, my husband. It is not correct to say that my husband was standing behind vehicle on middle of the road. I am not eyewitness of the accident. It is correct that my husband was standing behind Bolero. I know that there were some motorcycles. I do not know how many motorcycles were there. I do not know that there were 3 motorcycles behind Bolero. It is not correct to say that as 4 vehicles were standing on the road that created obstruction to the other vehicles running on road and alleged accident occurred. Suraj Sahare is friend of my husband. He was also on the spot at the time of accident. It is correct to say that he lodged report in the police station on the next day. It is not correct to say that accident occurred due to negligence of Bolero pick up and motorcycles parked on road illegally. I did not visit the spot. It is not correct to say that driver of

XUV 300 was not holding driving licence and that therefore, insurance company is not responsible to compensate the petitioners. It is not correct to say that our claim is false for exorbitant and excess amount.

5] My in laws own 13 acres of agricultural land. It is not correct to say that I have not produced document showing annual income Rs. 10 lacs of my husband. Now we do not cultivate agricultural land. I have not produced document showing that our agricultural land is kept barren. It is not correct to say that my claim is false and for excess and exorbitant amount. I have produced the documents of black gram on record.
