



ORDER BELOW EXH.1

This application is filed under Section 503 of the B.N.S.S

2. Applicant in the present application submitted that he is the owner of alleged muddemal i.e. Mahindra and Mahindra Companies car vehicle bearing registration No. MH-21-BQ-7111, Chassis No.MA1YU2XDUL6G12527 and Engine No.XDL4E11245 is seized by Police in Cr.No.305/2026 lodged under Sections 106(1), 281, 125(A), 125(B) of B.N.S. He submitted that the said muddemal is for daily use of the applicant and it is necessary to him for business and private work purpose. He further submitted that if the said muddemal is kept idle in the custody of the Police Station, Badnapur, there are possibility of damage. He is ready and willing to abide the conditions imposed by the Court. Therefore, he prayed that the seized muddemal be handed over to him.

3. On the other hand, Investigating Officer submitted his say, wherein he has not objected to release the seized muddemal and prayed that necessary order may be passed. Ld. A.P.P submitted that offence is serious in nature. If the vehicle is given to him, there is a possibility of transfer or modification in it. Hence, they prayed for rejection of the application.

4. I have perused record. Heard learned advocate for the applicant and learned A. P. P. for the State considered their

submissions.

5. Applicant has placed on record verified copy of RC book of muddemal, copy of insurance of vehicle, copy of Adhar Card and copy of F.I.R. After perusal of documents it appears that applicant is the lawful owner and possessor of the said muddemal. The objection taken by I.O and Ld. APP will be taken care by putting certain conditions.

6. As the applicant has shown that he is entitled for the possession of the same. Therefore, I pass the following order.

:- ORDER :-

1)	The application is allowed.
2)	Property namely Mahindra and Mahindra Companies car vehicle bearing registration No. MH-21-BQ-7111, Chassis No.MA1YU2XDUL6G12527 and Engine No.XDL4E11245 is seized by Police in Cr.No.305/2026 lodged under Sections 106(1), 281, 125(A), 125(B) of B.N.S. be handed over to the interim custody of the applicant, till the conclusion of the trial subject to following conditions :-
(a)	That the applicant shall produce all original documents of the said muddemal before the investigation officer for verification purpose.
(b)	Applicant shall execute indemnity bond of Rs. 15,00,000/- (Rupees Fifteen Lac only) on bond paper of requisite value.
(c)	Applicant to undertake that he will not dispose of, alienate, encumbrance, create third party rights or part with possession of the said muddemal without prior permission of the Court.
(d)	Applicant shall not change the engine number, chassis number and body of the said muddemal, till disposal of this case.

(e)	Applicant shall not use the said disputed muddemal in commission of any kind of offence again.
(f)	Applicant shall produce the said muddemal before Police Station, Badnapur as and when required.
3)	The I.O. of the present crime is hereby directed to draw detailed panchanama of the said muddemal, verify chassis number & engine number of the said vehicle and capture photograph of the said Muddemal before handing it to the applicant. IO is further directed to attach all these copies along with the charge sheet.
