This is an application for grant of Legal Heir Certificate under
Sec. 3 and 7 of the Bombay Regulation Act.

2] In short, the applicants have come up with the case that, they are the son of deceased Malanbai Ashroba Kharat, who died on 10/08/2025 at Mauje Gewarai, Taluka- Mantha, District- Jalna. The applicants are the only legal heirs of deceased Malanbai Ashroba Kharat. Therefore, the applicants prayed to grant legal heir certificate.

3] The paper publication vide Exh.08 was made in the daily newspaper "Jagmitra" dated 09th May, 2026 and objections were called upon to be filed within one month. So also, notice was affixed on conspicuous place of the Court. But, none appeared to contest the matter and accordingly this application is being disposed of as uncontested one.

4] I have heard the learned advocate for the applicants. Perused the evidence of applicant No.2 at (Exh.09), death certificate of deceased Malanbai Ashroba Kharat (Exh.10), verified copy of his Aadhar Card (Exh.11) and public notice at (Exh.08). Thereafter, the applicants have filed evidence close pursis (Exh.12).

5] There is no denial to the evidence of the applicant. So also, there is no objection raised by anybody. The applicants have furnished necessary documents to succeed their claim.

6] Upshot of the above, I have no reason to disbelieve the version of applicant on oath and, therefore, applicants will be entitled for getting legal heir certificate as requested for. Thus, the above referred evidence makes it clear that the applicants are entitled for legal heir certificate. In the result, I pass the following order.

ORDER

- 1] Applicant 1) **Tarachand Ashroba Kharat** & 2) **Rajebhau Ashroba Kharat** are formally recognized as entitled for Legal Heir Certificate, in respect of Malanbai Ashroba Kharat.
- 2] Issue Legal Heir Certificate to the above applicants after payment of requisite stamp and court fees, if any.
- 3] Nazir/A.S. to verify the valuation required for issuing Legal Heir Certificate.
