**ORDER BELOW EXH.1 IN CRI. MISC. APPLICATION NO.75 OF 2026**

(Lt.Sunita Sanjay Londhe Thr. LRs Sanjay Bhagwan Londhe Vs. State of Maharashtra )

1] Applicant Sanjay Bhagwan Londhe has filed this application under section 503 of the Bharatiya Nagarik Suraksha Sanhita to release Suzuki Co. Access 125 scooter bearing No. MH-09-FX-8308, which is seized during investigation in C.R. No.29/2026 registered at Kodoli Police Station. According to applicant, wife of applicant viz. Lt. Sunita Sanjay Londhe died on 23/10/2023. She is owner of said vehicle. After the death of Lt. Sunita Londhe, applicant was using said vehicle for his domestic and day to day work. Applicant requires his vehicle for business use. If it remained in Police Station, it will damage. Therefore he prayed to return his scooter.

2] I.O. and APP filed say stating that applicant used said vehicle in offence. There is possibility of repetition of same kind of offence. So they prayed to reject the application.

3] Applicant has produced verified copy of Smart Card, insurance policy, FIR copy, his Aadhaar card and death certificate of his wife. Advocate of applicant submitted that police seized vehicle from son of applicant i.e. accused. Applicant never used said vehicle in any illegal activity. As per verified copy of Smart Card, wife of applicant is the registered owner of Suzuki Co. Access 125 scooter bearing No. MH-09-FX-8308. Applicant is the legal heir of deceased Sunita Sanjay

Londhe. After demise of wife of applicant, applicant is using the said vehicle. Applicant is not accused in this case. Applicant wants said vehicle for his business use. The seized vehicle will be damaged, if it is kept in idle condition in police station. Except applicant nobody claimed the said vehicle. Applicant is entitled to release of Suzuki Co. Access 125 scooter bearing No. MH-09-FX-8308 in his favour. For these reasons, the application deserves to be allowed. Therefore following order is passed-

**ORDER**

- 1] Application is allowed.
- 2] Suzuki Co. Access 125 scooter bearing No. MH-09-FX-8308, Chassis No. MB8DP12DMM8985054, Engine No. AF212713900 be released in favour of applicant Sanjay Bhagwan Londhe on execution of Suprutnama Bond of Rs.50,000/- on following conditions-
  - a] Applicant shall not dispose of above mentioned Scooter in any manner till disposal of this case.
  - b] Applicant shall produce before the court the seized vehicle as and when required.
  - c] Applicant shall not use the vehicle in any offence or illegal activity.
  - d] Yadi be issued to Kodoli Police Station.
- 3] Since the application is filed online, separate physical copy of this order is not maintained. All concerned to act upon digitally signed copy of this order uploaded online.
