**APPLICATION FOR EXTENSION OF TIME TO COMPLY WITH THE CONDITIONAL
ORDER OF DEPOSIT, FOR ACCEPTANCE OF THE AMOUNT NOW BEING DEPOSITED
AND FOR RECALL/KEEPING IN ABEYANCE THE WARRANT ISSUED AGAINST THE
APPELLANT**

Herein the Applicant/Appellant most respectfully submit as under:

1. The above Criminal Appeal is pending before this Hon'ble Court.
2. By order dated 19/06/2026 this Hon'ble Court was pleased to suspend the sentence/stay the execution of the impugned judgment and

order, subject to the condition that the Applicant shall deposit (20% of compensation amount of Rs.2,20,000/-) i.e. Rs.44,000/-.

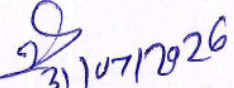
3. Pursuant to the said order, the Applicant immediately deposited a sum of Rs.10,000/- and was making sincere efforts to arrange the balance amount.

4. Unfortunately, during the said period, the Applicant suddenly fell seriously ill on account of viral fever due to change in atmosphere and remained under medical treatment at Annapurana Nursing Home ,Samratnagar,Kolhapur of Dr.Sharad J.Topkar. He was bedridden for considerable time and had to incur substantial medical expenses towards hospitalization, medicines and follow-up treatment. Copies of the relevant medical papers are annexed herewith.

5. Owing to the aforesaid unavoidable circumstances, the Applicant could not arrange and deposit the remaining amount within the stipulated period. The default was neither intentional nor deliberate, but occurred solely due to circumstances beyond his control.

6. Since the Applicant could not comply with the condition within time, it is learnt that this Hon'ble Court was pleased to issue a warrant against him.

7. The Applicant has the highest regard for the orders of this Hon'ble Court. He has never intended to evade the process of law. The Applicant is now in a position to deposit a further amount of Rs.34,000 immediately and undertakes to deposit the remaining balance amount within such period as this Hon'ble Court may deem fit and proper.

8. The Applicant has a good arguable appeal. If the warrant is executed without granting reasonable time to comply with the conditional order, the Applicant will suffer irreparable loss and the appeal itself may become infructuous so far as the benefit of suspension of sentence is concerned.

9. No prejudice whatsoever will be caused to the Respondent if a reasonable extension of time is granted, whereas refusal of the present application would cause serious hardship to the Applicant despite his bona fide conduct.

10. The present application is made bona fide and in the interest of justice.

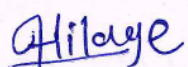
PRAYER

- (a) Extend the time for compliance with the order dated 19/06/2026 directing deposit of 20% of the cheque amount;
- (b) Accept the amount of Rs. 34,000 being deposited by the Applicant today and permit him to deposit the remaining balance within such time as this Hon'ble Court deems fit;
- (c) Recall the warrant issued against the Applicant, or in the alternative, keep the same in abeyance till the expiry of the extended period granted by this Hon'ble Court;
- (d) Pass any other order which this Hon'ble Court deems fit.

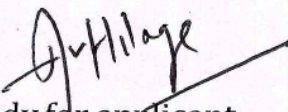
