
**ORDER**

Today, accused is present. The particulars of offence are read over to accused. He voluntarily pleaded guilty to offence. He also filed an purshis stating that he is voluntarily pleading guilty to the said offence and prayed to impose minimum punishment. Considering the nature of offence and taking in view the voluntariness of accused, his plea of guilt is accepted and leniency can be shown so far as substantive sentence of imprisonment is concerned. In the result, I pass following order:-

**ORDER**

- (i) Accused is convicted for offence under Sections 128(1)/194(c) and 3(1)/181 of Motor Vehicles Act *vide* Section 252 of the Code of Criminal Procedure.
- (ii) Accused is sentenced to pay fine of **Rs. 1000/-** for the offence punishable under R 128(1)/194(c) of Motor Vehicles Act, in default, accused shall suffer S.I. for 01 (One) day.
- (iii) Accused is sentenced to pay fine of **Rs.2000/-** for the offence punishable under section 3(1)181 of Motor Vehicles Act, in default, accused shall suffer S.I. for 01 (One) day.
