ORDER

Today, accused is present. The particulars of offence are read over to accused. He voluntarily pleaded guilty to offence. He also filed an application/ purshis stating that he is voluntarily pleading guilty to the said offence and prayed to impose minimum punishment. Considering the nature of offence and taking in view the voluntariness of accused, his plea of guilt is accepted and leniency can be shown so far as substantive sentence of imprisonment is concerned.
